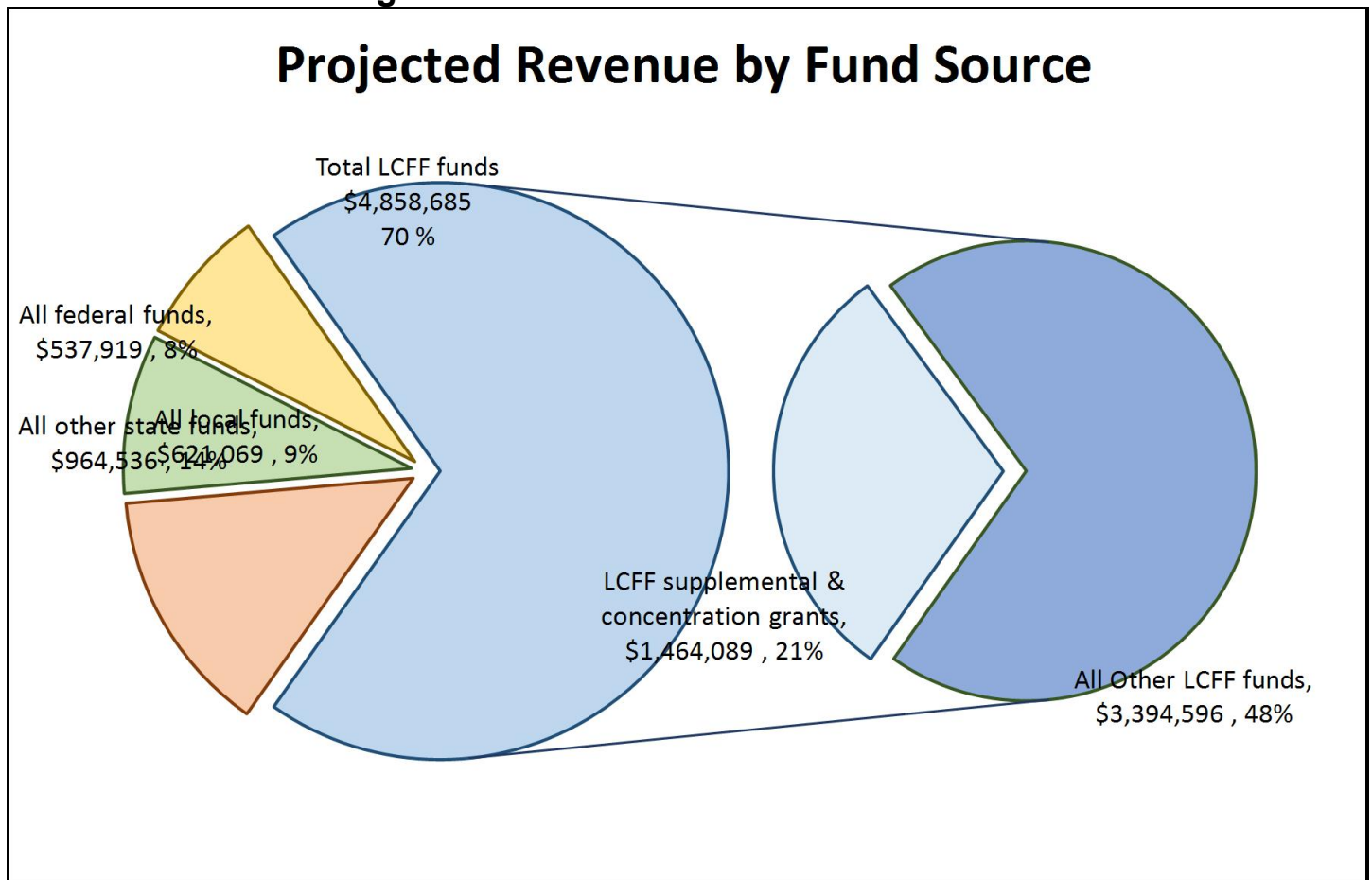

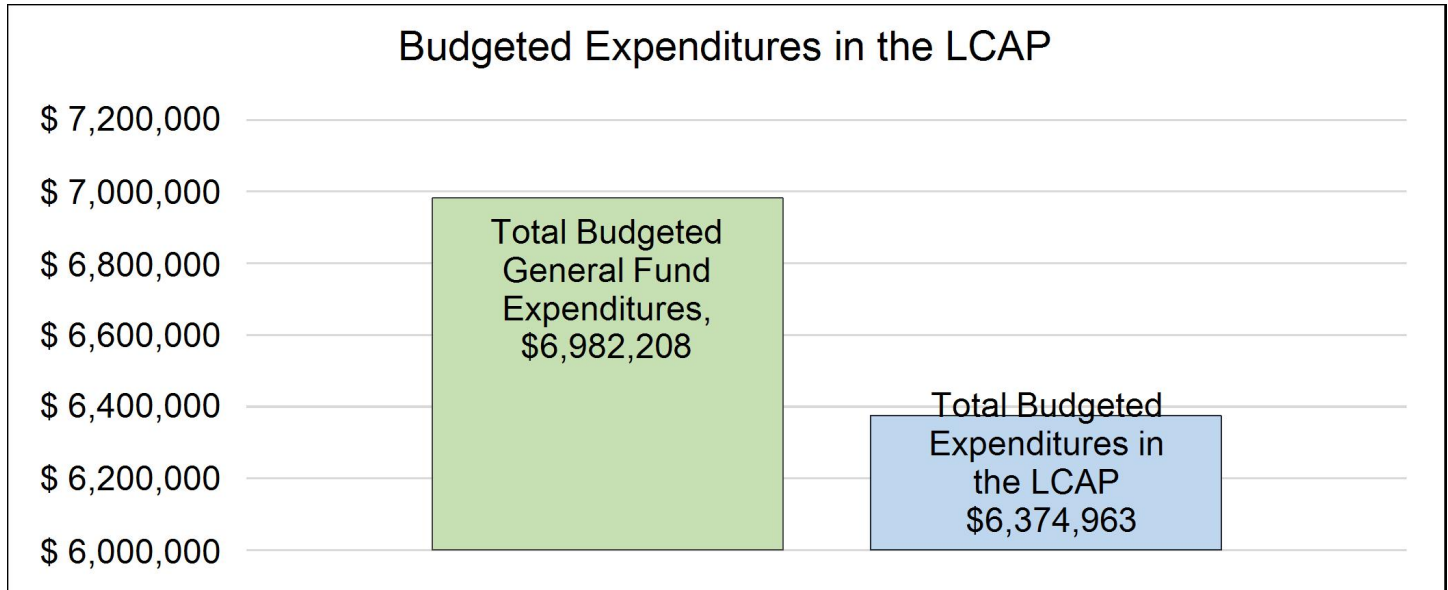


This chart shows the total general purpose revenue **Ánimo Compton Charter School** expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for **Ánimo Compton Charter School** is \$6,982,209, of which \$4,858,685 is Local Control Funding Formula (LCFF), \$964,536 is other state funds, \$621,069 is local funds, and \$537,919 is federal funds. Of the \$4,858,685 in LCFF Funds, \$1,464,089 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

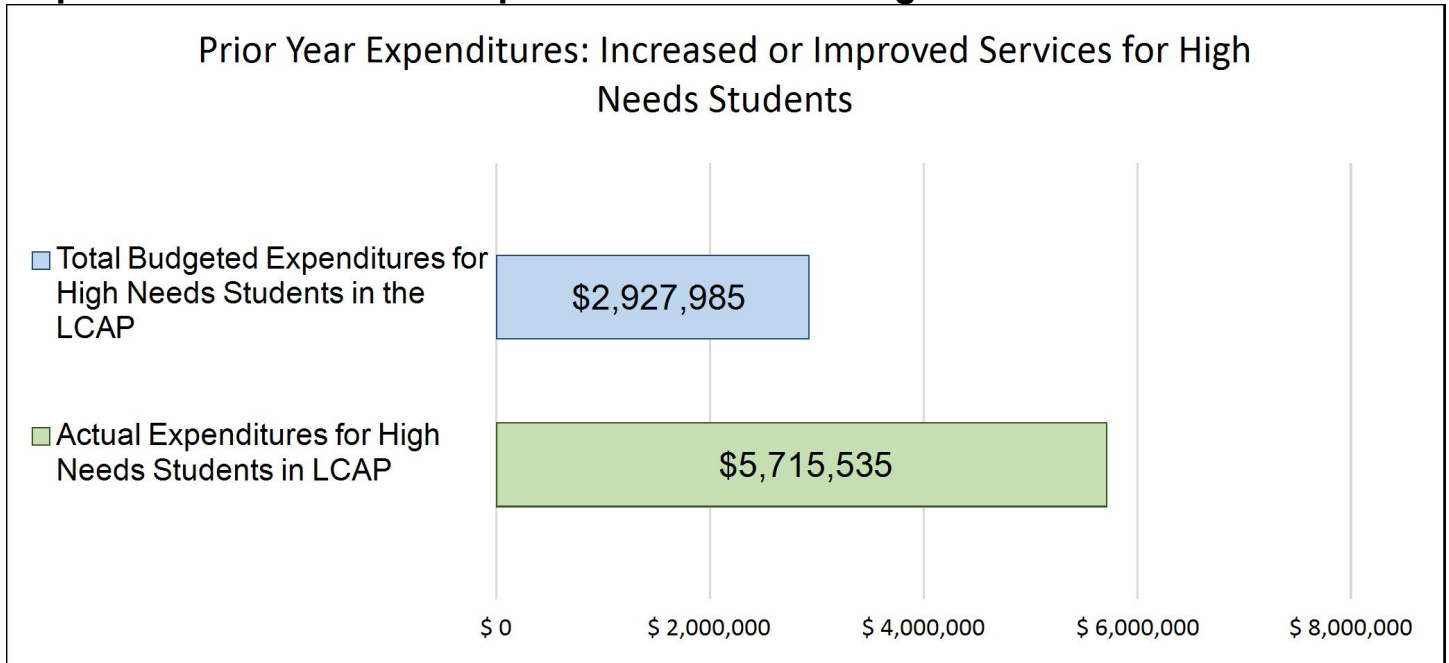

Overall, the school was effective in implementing the actions & services to ensure students are prepared for college, leadership, and life. We provide a number of supports to ensure students are successful in this area, and are prepared for their future endeavors. There were no substantive differences in the planned actions and actual implementation of these actions. We were able to meet all of the metrics for Goal 1.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

The original projected budget for the 2023-24 school year underestimated the salary ranges for teachers, school administrative staff, and new hires. The 2023-24 Actual Expenditures were higher than planned as the original budget did not account for a competitive market to retain and attract quality staff. This underestimation led to increased personnel costs in relation to salaries. Thus, resulting in material differences between planned and actual expenditures.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

We were effectively able to meet all of the metrics in Goal one through the actions described in our LCAP last year. This includes successes in master scheduling to ensure all credentials are properly maintained. In addition, our curriculum adoption was successful and teachers were able to implement the use of curriculum with fidelity, ensuring student access to all curricular materials. Lastly, our facility inspections ensured that our facilities were well maintained to support student learning.

Overall, the school was effective in implementing the actions & services to ensure students are prepared for college, leadership, and life. We provide a number of supports to ensure students are successful in this area, and are prepared for their future endeavors. There were no substantive differences in the planned actions and actual implementation of these actions.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

The original projected budget for the 2023-24 school year underestimated the salary ranges for teachers, school administrative staff, and new hires. The 2023-24 Actual Expenditures were higher than planned as the original budget did not account for a competitive market to retain and attract quality staff. This underestimation led to increased personnel costs in relation to salaries. Thus, resulting in material differences between planned and actual expenditures.

As it relates to curriculum expenditures, more funds were spent on enhancing the curriculum through arts and music block grants. Our investment with this grant funding provided an enriched educational experience that is the root of material differences between actual expenditures compared to planned.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

For LCAP Goal 2a, SBAC ELA, we did not meet the metric outlines in our LCAP goals. While our actions taken did support student learning, we know that some actions were not successful in achieving the desired results. For example, our professional development did not improve student outcomes in the desired way, so for this year we revamped our PD to have more of a focus on instructional rigor. In addition, we prioritized new teacher PD to support our new teachers and long term subs to help them improve their instructional quality. Furthermore, we intensified our partnership with our curriculum specialists to prioritize coaching for new teachers. Our interim assessments and test preparation were also not as effective as we'd hoped, so we revamped those initiatives for this school year, ensuring that all students in grades 6th-11th receive one hour of grade level test preparation per week. Teachers have also begun using an online assessment platform to prepare students for the online SBAC and to gather data regarding student performance based on standards. Lastly, we did a mock SBAC for middle school and 11th grade through a collaborative efforts between our humanities departments, followed up by a data analysis and planning session.

For goal 2b, our major challenge was that we did not have a math teacher for 11th graders last year. We tried to mitigate that challenge through the use of the online learning platform, Edgenuity, however, it was not successful in meeting our data goals. This year we have a full-time, credentialed teacher in all math courses. Additionally, we have additional math tutoring built into our day through our High Impact Tutoring program and SBAC prep tutoring. We also revamped our interim assessments for our math department and have begun to use an online platform to be able to do more strategic data analysis to plan for reteaches.

For goal 2c, again our challenge was that we did not have a high school science teacher for our 11th grade cohort of students. This year we were able to partner with strong long-term substitute teachers and intensify our support for our science teachers through our partnership with two science curriculum specialists.

For goal 2d, we did meet our goal, and had several successes in actions taken towards meeting this goal. We held 6 DELAC meetings in which we discussed student progress, the ELPAC, and strategies to support student learning at home.

For goal 2e, ELPI levels, we narrowly missed our goal. Our successes were in having 3 ELD specific PD's to support teacher instruction regarding Emergent Bilinguals. While our ELPI levels did not increase as much as we thought they would, so we adjusted our ELD PDs for this year to better meet the needs of our students based on ELPI data analysis.

Entering the new 3-year LCAP cycle that begins with the 2024-25 LCAP, we have focused and refined the language in our actions to reflect the efforts and vision for the next 3 years. Additionally, we have added a new Action specifically addressing our whole-school red indicator Mathematics and English Language Arts outcomes on the 2023 CA School Dashboard. For our students groups, we have added Actions addressing English Language Arts red indicator outcomes on the 2023 CA School Dashboard for English Learners. We have also added Actions addressing English Language Arts and Mathematics red indicator outcomes for African American students.

For Goal 3, we only have data on metric 3F, which we met our goal. We do not have data on the other metrics for Goal 3 yet as the class of 2024 will be our first graduating class of seniors. However, we have made extensive support towards the other metrics by utilizing a senior counselor who has worked with our seniors to ensure they are graduating A-G ready. Additionally, we have worked with our AP teaching team to ensure our AP scholars are ready for the AP exams through rigorous instruction and exam preparation. Our actions were effective in supporting our LCAP metric outcomes and we will continue to work through implementation and measuring of effectiveness.

Entering the new 3-year LCAP cycle that begins with the 2024-25 LCAP, we have focused and refined the language in our actions to reflect the efforts and vision for the next 3 years. Average Daily Attendance (ADA) has not recovered from pre-pandemic levels and it was necessary for use to increase spending on staffing and services to address the supports that students need to encourage regular attendance. Difficulty in increasing ADA and the related need for additional resources incurred material differences in planned and actual expenditures.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

For Goal 4, we have had several success. First, in maintaining an ADA for all subgroups except our Emergent Bilinguals. To address this challenge, our SART team has made personal outreach to families to ensure our EB's attend school on a regular basis. Actions that have yielded positive results included taking regular attendance, our SART process, and using our data dashboard to monitor attendance. Our challenge has been with Chronic Absenteeism (metric 4b), in which we did not meet our goal for several subgroups; however, we did meet it for our African American and Students with Disabilities. To address these challenges with chronic absenteeism, we have utilized Early Warning Indicator meetings and the support of our African Achievement Specialist to make personalized phone calls to families to offer support for our chronic absentee families.

For the metrics of 4c and 4d, we met our performance goals, effectively keeping our suspension and expulsion rates low. This has been through the efforts of implementing our Tier 1 strategies through Advisory. Furthermore, our COST (mental health team) supported students with Tier 2 and 3 behaviors, through counseling, mediation, and group therapy, thus keeping Tier 2 and 3 infractions to a minimum.

The original projected budget for the 2023-24 school year underestimated the salary ranges for teachers, school administrative staff, and new hires. The 2023-24 Actual Expenditures were higher than planned as the original budget did not account for a competitive market to retain and attract quality staff. This underestimation led to increased personnel costs in relation to salaries. Thus, resulting in material differences between planned and actual expenditures.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

For Goal 5, we met all of our metrics except one, parent participation, which was a data recording error. We have worked to remedy this challenge by ensuring we keep accurate record of our parent participation in events. All other metrics in Goal 5 were met. This was due to the actions we took that ensured parent and staff feedback and participation in shared decision making committees. Additionally, we strived to ensure that families and staff have a positive experience at our school, thus giving positive ratings on the family and staff surveys. Some of the actions that demonstrated success are our effective communication with parents through regular family newsletters, hosting monthly family/parent events such as workshops and coffee with the principal, and other activities to engage our parents in the school community. Moreover, as a community school, we have worked to engage our families through partnerships that have provided services to families both on and off campus. Lastly, staff surveys demonstrate that that they feel successful in their role, as teachers are engaged in meaningful collaboration through SAC, DELAC, ILT, ACT, and other shared leadership roles and opportunities.

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Ánimo Compton Charter (ACCS) is a public 6-12 span school that opened in 2018 to the Compton and surrounding community. The school's vision is to empower ourselves and others to live the dream through leadership development, enriching experiences, academics, and dedication to self, family, and community. The school achieves our vision by providing a small, college preparatory program where all educational partners (students, families, teachers, staff, and community members) are actively engaged. We emphasize our college-going culture by organizing tours, leadership speakers, and including annual research projects.

The school currently serves 318 students in grades 6-11; approximately 37.1% African American, 60.4% Latino students, 89% of students are socioeconomically disadvantaged, 19.5% are students with disabilities, and 20.1% are English learners. We will continue to grow until we span from 6th –12th grade. At Ánimo Compton, we approach leadership through empowerment — supporting students in finding their unique voice, and teaching them how to use it with confidence and passion, so they can make a difference. We teach students that they can do anything they set their mind to with what they already have. Ánimo Compton's leadership-focused curriculum equips and empowers students to develop a sense of agency and determination so they can enact change for themselves and their community. Through a wide array of course offerings in leadership, on and off campus —including a monthly speakers series, leadership clubs, internship and mentorship opportunities — Ánimo Compton's leadership-focused curriculum aims to encourage its students to become leaders of their own lives. The school's leadership curriculum nurtures students' sense of self-worth, builds upon the assets of their families and communities, and teaches the skills of self-motivated leadership.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

On the CA Data Dashboard, we demonstrated successes in three categories: reducing chronic absenteeism, suspension, and ELPI growth. Our areas of challenge were in our ELA and Math performance data. Our ELA and math data were in the red, highlighting the need to make

strategic moves to improve outcomes. Some challenges we faced last year, included that more than half of our team were first year teachers, and we had a number of unfilled teacher vacancies in which we used long term subs. This was true for our 11th grade math position, so students used an online learning program, Edgenuity, with the support of a long term sub. We were able to address that particular challenge by hiring a math teacher for that position. Additionally, we continued our partnership with the data consulting group, Lavinia Group, to support our data analysis and strategic planning for both ELA and math. Consultants from Lavinia Group provided academic coaching to both admin and teachers to improve instructional outcomes in the classroom. We also increased our coaching with curriculum specialists who intensified their frequency of coaching with our new teachers and current long term subs. Furthermore, we focused on instructional rigor in staff professional development, and also provided differentiated PD to our new teachers and long term subs, following the model of Get Better Faster. In department time, our ELA and math teams focus on student work analysis in order to plan for re-teaches to help close learning gaps.

Reflections: Technical Assistance

In winter 2024, our school was selected for Differentiated Assistance based on the performance of Hispanic students, African American, English Learners, and Socioeconomically Disadvantaged. With this designation, we recognize a need and an opportunity for growth and development in exceeding the outcome requirements for LCFF Priorities 4 (Pupil Achievement) and 5 (Pupil Engagement). We have engaged with the Los Angeles County Office of Education to explore innovative strategies and tailored support systems to improve these student group outcomes. As we enter the next school year, we anticipate that as we work with LACOE's collaborative guidance it will enable us to implement impactful initiatives aimed at fostering student success throughout the upcoming 2024-25 school year.

Additional Concentration Grant Funding

A description of the plan for how the additional concentration grant add-on funding identified above will be used to increase the number of staff providing direct services to students at schools that have a high concentration (above 55 percent) of foster youth, English learners, and low-income students, as applicable.

Our LEA has been using our Additional Concentration Grand funding to hire staff to provide direct services for our unduplicated student groups. Below we outline our efforts in regards to Free and Reduced Lunch, English Learners, and Foster Youth. Additional Concentration Grand funding supports increasing the number of credentialed staff to ensure that students receive personalized academic assistance to meet grade-level standards. These funds were also used to hire instructional staff trained to implement and support the i-Ready diagnostic and instructional program. These staff members provide direct services, ensuring personalized learning paths are effectively utilized. Schools demonstrating the greatest need for diagnostic assessments and personalized instruction received additional staff to maximize the impact of the i-Ready program. Funding supports the hiring of credentialed elective teachers to offer courses like Project Lead The Way (PLTW) and AEE, providing students with hands-on, project-based learning experiences in STEM and the arts. As we are continuing to push forward from

the onset of the Covid-19 pandemic, we are focused on reducing Chronic Absenteeism rates, specifically for our unduplicated students. Funds are allocated to hire additional staff focused on reducing chronic absenteeism, utilizing programs like Everyday Labs and Attendance Works to engage with students and families directly. The grant funds are used to hire and support credentialed staff that manage and implement the Ellevation platform, providing targeted instructional strategies and support to English learners. Funds are used to hire additional staff to manage and curate diverse reading materials for classroom libraries, specifically for middle school English learners. This funding supports our initiative and mission to support and increase literacy outcomes for our unduplicated students. Supporting Foster Youth and Homeless students is a high priority given our region's area of need. This funding supports the hiring of additional credentialed staff to deliver a specialized advisory curriculum tailored to the needs of foster youth and homeless students, addressing their social-emotional and academic challenges. The grant funds additional staff to run Summer Bridge programs, assisting foster youth and homeless students in transitioning between grade levels or new schools with academic and social-emotional support. Funds are used to hire case managers and form partnerships with external mental health organizations, providing comprehensive mental health services to foster youth and homeless students

 - This percentage is the total of the Planned Percentage of Improved Services column.
- **Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)**

- This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

Contributing Actions Annual Update Table

Pursuant to *EC* Section 42238.07(c)(2), if the Total Planned Contributing Expenditures (4) is less than the Estimated Actual LCFF Supplemental and Concentration Grants (6), the LEA is required to calculate the difference between the Total Planned Percentage of Improved Services (5) and the Total Estimated Actual Percentage of Improved Services (7). - This amount is the total of the Planned Percentage of Improved Services column.

- **8. Total Estimated Actual Percentage of Improved Services (%)**

- This amount is the total of the Estimated Actual Percentage of Improved Services column.

- **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**

- This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

LCFF Carryover Table

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**

- This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**
 - If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.
- **13. LCFF Carryover — Percentage (12 divided by 9)**
 - This percentage is the unmet portion of the Percentage to Increase or Improve Services that the LEA must carry over into the coming LCAP year. The percentage is calculated by dividing the LCFF Carryover (12) by the LCFF Funding (9).
