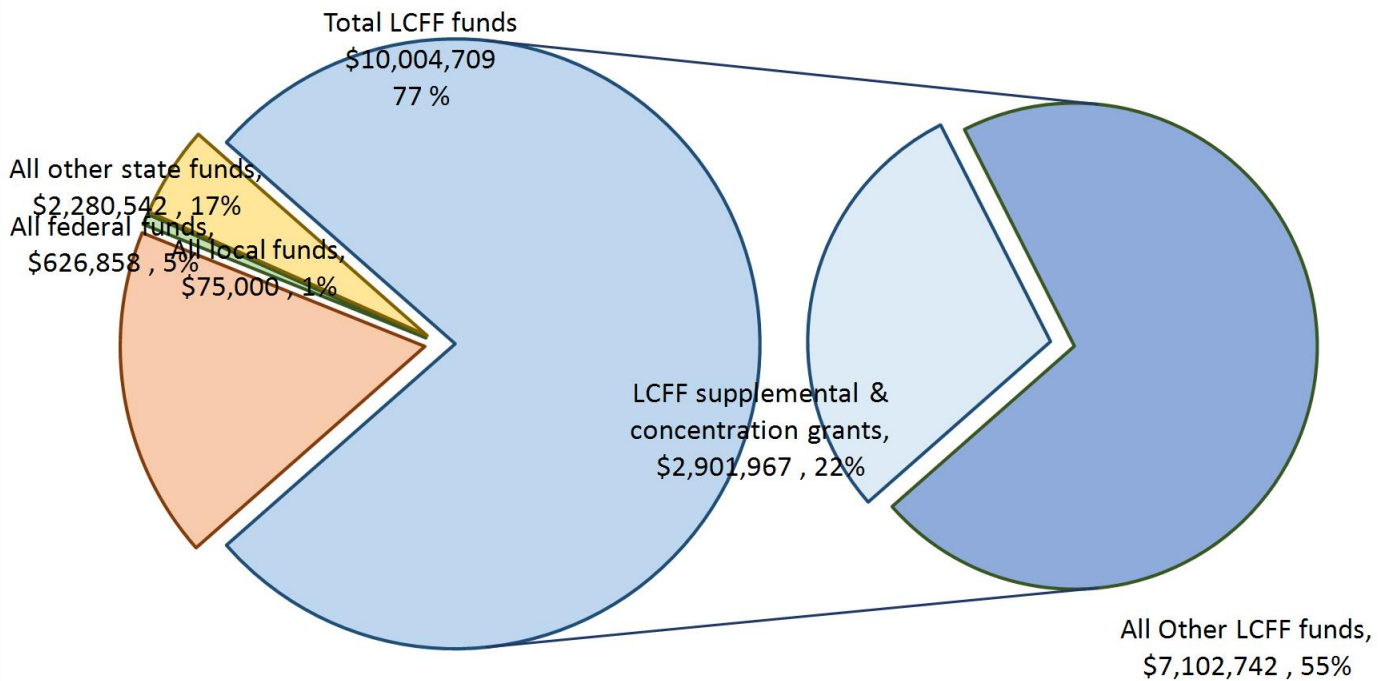

Projected Revenue by Fund Source

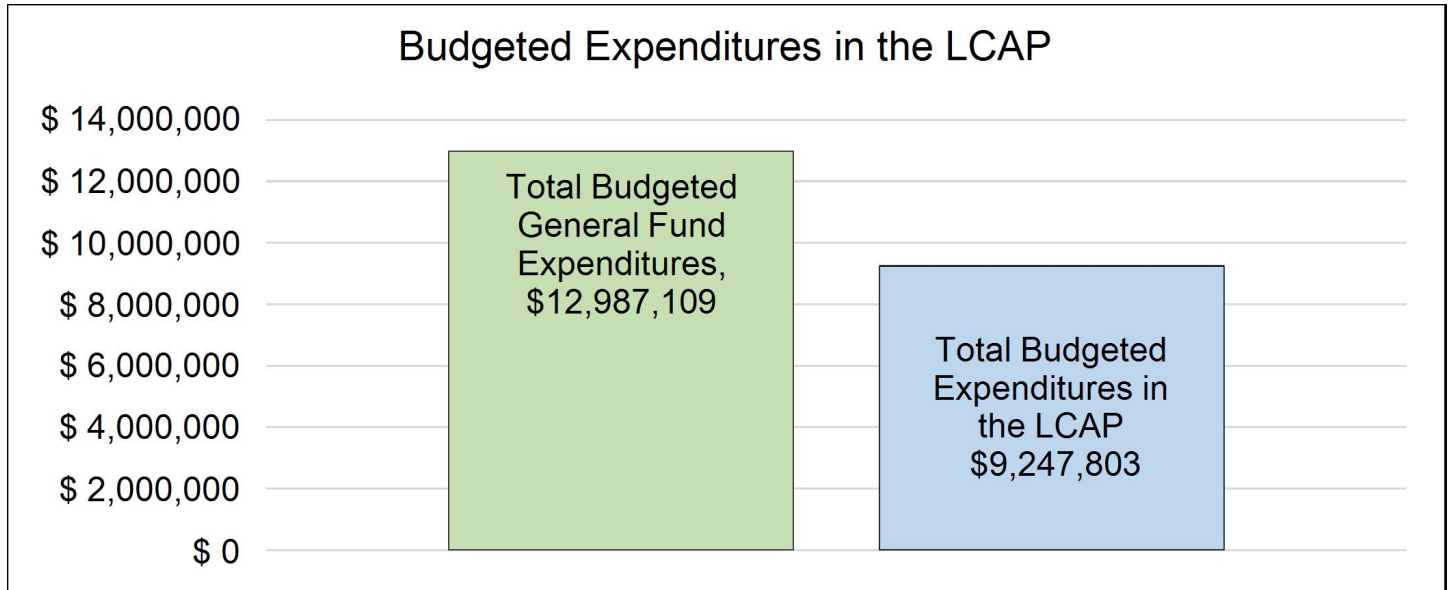


This chart shows the total general purpose revenue *Ánimo Inglewood Charter High School* expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for *Ánimo Inglewood Charter High School* is \$12,987,109, of which \$10,004,709 is Local Control Funding Formula (LCFF), \$2,280,542 is other state funds, \$75,000 is local funds, and \$626,858 is federal funds. Of the \$10,004,709 in LCFF Funds, \$2,901,967 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

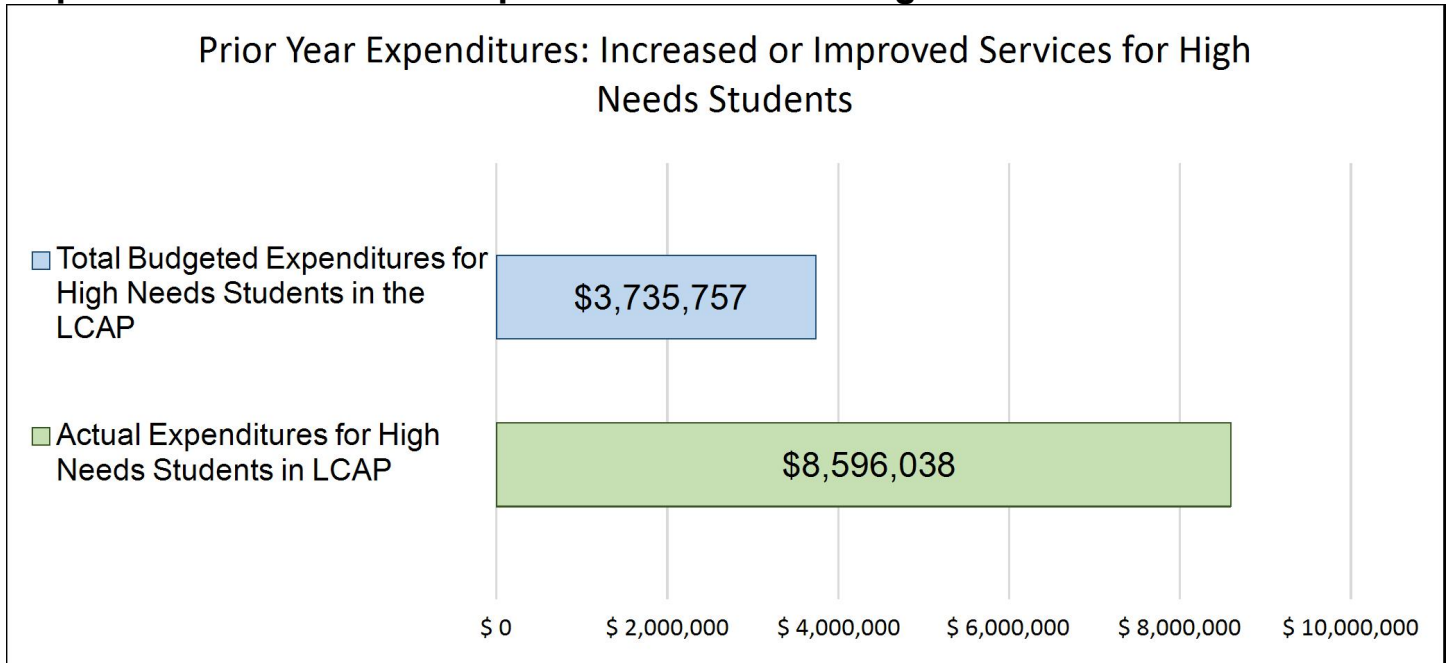

"Overall Implementation:

1.1: Green Dot Home Office works with school leaders to maintain credentialed teachers. AICHS met this goal with a 100% performance rate. All our teachers are credentialed.

1.2: Green Dot Home Office works collaboratively with schools on curriculum implementation. AICHS met this goal with a 100% performance rate, as all of our teachers in our core classes use standards-based curriculum and materials.

1.3 We ensure that all students participate in PE, VAPA, and other electives in order to meet high school graduation and A-G requirements as outlined in our charter petition.

1.4: Green Dot Home Office in conjunction with school site personnel conduct regular facilities inspections to ensure that facilities are in good repair. AICHS met this goal with a 99% performance rate. Our facilities are in good repair.

Our school did not have any substantive differences in planned actions and the implementation as seen on the metric outcomes.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

The original projected budget for the 2023-24 school year underestimated the salary ranges for teachers, school administrative staff, and new hires. The 2023-24 Actual Expenditures were higher than planned as the original budget did not account for a competitive market to retain and attract quality staff. This underestimation led to increased personnel costs in relation to salaries. Thus, resulting in material differences between planned and actual expenditures.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

AICHS met all the metrics of Goal 1 with at least a 99% performance rate. All our actions were effective as displayed by these outcomes.

Overall Implementation:

AICHS has implemented all the actions outlined in the adopted LCAP.

2.1: Curriculum, Resources and Materials to Support Student Subgroups

AICHS continues to offer ELA and math intervention courses at the 9th and 10th grade levels to ensure support for students below grade level. Teachers receive professional development that is aligned to rigorous instruction and focuses on providing tiered supports and interventions. AICHS uses Common Core aligned curriculum that both teaches to the state standards and gives students exposure to the structure and format of the CAASPP. Curriculum aligned assessments assess students on grade level standards.

2.2: Supports for EL Students

AICHS delivers professional development for teachers specifically focused around Emergent Bilingual scholars, helping them identify their language acquisition level and what teaching strategies will help support their language growth. We have found it challenging to ensure that our EB scholars receive language instruction in all their classes outside fo their ELD course. We have focused on ensuring that all teachers are trained on the Ellevation platform to analyze student data and learn new EB instructional strategies. ELlevation also serves as a progress monitoring and accountability platform where all teachers are expected to indicate the instructional support provided to scholars. This resource allows teachers to differentiate based on EB scholar needs. In addition to using ELlevation, teachers across all content areas have received PD on creating language criteria for success for their lessons so that EBs are supported with language development.

2.3: Special Education

AICHS continues to ensure that all our students with IEPs are receiving instruction in the least restrictive environment. We provide a blended special education model in which inclusion is embraced and students receive their service minutes through push-in support and academic success classes. Our team is comprised of mental health support staff, teachers, office staff, aids, service providers, administrators, program specialists, and transitional support staff to ensure that we provide integrated supports that address the needs of our students with disabilities. Our master schedule is created each year to ensure that our special education program can provide all the necessary services to each of our students. Additionally, we provide professional development to our teachers focusing on instructional strategies and accommodations and modifications for SWD. The team also analyzes discipline data to ensure that students with disabilities are receiving appropriate support in the area of social emotional supports.

2.4: High Achieving Students

Eligible students have a myriad of AP courses available to them. We continue to add AP course offerings each year.

2.5: Professional Development

Teachers participate in one professional development session and one collaboration session per week. Professional development focuses on the process of Intellectual Preparation so that teachers are planning effectively with aligned curriculum and the Common Core or Next Generation Science standards. We also provide PD around EB and SWD specific subgroups and participate in data analysis in order to ensure our subgroup performance is on par with our student body as a whole.

2.6: Interim Assessments:

As a part of the Green Dot Public Schools organization, AICHS administers common assessments for math. We have quarterly assessments that are aligned with our curriculum for our core math, ELA, and science classes.

2.7: Test Preparation

AICHS utilizes the online test preparation resources available through the CDE or other curriculum supplements and Ed team created resources to support students for assessments

2.8: Credit Recovery

ELA and Math intervention courses (Literacy Intervention, Math Support, Academic English Essentials, Composition 9) are offered at the 9th and 10th grade levels to ensure students below grade level have targeted supports to meet their needs. Our master schedule is developed to create multiple pathways for students to meet the A-G requirements, which align to the minimum requirements for a Green Dot HS diploma. AICHS has three counselors who provide academic and college counseling. Additionally, we have a college success advisor who works with a subgroup of our senior class to give directed support as they apply to colleges and universities. All students take an Advisory course for four years which provides individualized academic consultancy and a review of graduation progress in addition to counselor check-ins and tracking. Credit recovery is offered to support students in need of recouping credit either on site or from outside agencies with connections facilitated by our counseling department.

The original projected budget for the 2023-24 school year underestimated the salary ranges for teachers, school administrative staff, and new hires. The 2023-24 Actual Expenditures were higher than planned as the original budget did not account for a competitive market to retain and attract quality staff. This underestimation led to increased personnel costs in relation to salaries. Thus, resulting in material differences between planned and actual expenditures.

As it relates to curriculum expenditures, more funds were spent on enhancing the curriculum through arts and music block grants. Our investment with this grant funding provided an enriched educational experience that is the root of material differences between actual expenditures compared to planned.

Most of the actions listed were implemented without substantive difference from their description in the adopted LCAP.

We experienced challenges with a few of the actions. We were unable to offer summer retreats and full mock assessments to our students in AP courses. Additionally, we had teachers new to the AP content. As they gain familiarity with their courses, we anticipate an increase in AP pass rates in subsequent years.

Overall Effectiveness:

We believe all our actions are effective as seen by our metric outcomes. There were staffing challenges as we did not fully staff our summer staff AP prep role. We need to consider moving forward if this is a reasonable ask by taking all our other summer programming into consideration.

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Ánimo Inglewood Charter High School was founded in 2002 as the second school of the Charter Management Organization Green Dot Public Schools CA. Ánimo Inglewood is located in South Los Angeles, in the city of Inglewood, serving students in grades 9-12. It is a free and public charter high school, and functions as a community school for students who primarily live within the Inglewood, California area. Current enrollment numbers show that Ánimo Inglewood currently serves 596 students. The racial backgrounds of our students are majority Latino & African-American- with 10.2% of our student body identifying as African-American, and 89.3% Latino. Additional student groups include our English Learners at 7.2% and 6.9% Students with Disabilities. The mission of Ánimo Inglewood Charter High School is to “prepare ethnically and economically diverse students for college, leadership, and life through innovative instruction, a rigorous curriculum, and the use of technology.” Our mission was fully exemplified in the 2023-24 school year when we were recognized as a California Distinguished School. Only 1 of 51 such schools to be identified in the Los Angeles area.

In the 2020-21 school year AICHS improved our cohort dropout rate by taking it down to 0%. In the 2021-22 school year we maintained it at 0%. In 2022-23 our drop out rate remained very low, at 2%. In 2020-21 we increased our A-G readiness percentages to 86% and, though it dropped to 74% in 2021-22, we are already seeing A-G growth. In the 2022-23 school year our A-G readiness was 86%. We have maintained a high percentage of at least 97% of students graduating from high school. 0% of students were suspended or expelled in 2022-23, maintained from the prior two years.

We met all the metrics of goal 2 and dramatically outperformed our goals for SBAC and CAST performance, overachieving in ELA by 44%, math by 13%, and science by 37%. Our SGP in ELA was 99% for the 2022-23 school year and our math 87%. In EL reclassification, we tripled our growth goal.

Our overall attendance rate is at least 93%, our overall retention rate of both students and teachers is extremely high. Overwhelmingly, families indicate satisfaction with the school and rate they would recommend the school, year after year. In terms of students recommending the school, we achieved 97% on the satisfaction survey. Teachers also stay at AICHS, indicating that they appreciate and contribute to the

positive school culture we have created at our school. We achieved a 97% in teacher satisfaction on their survey last year. These highlights indicate that we are building a learning community that is both challenging and nurturing to all our students.

The LCAP data reflected a need to focus on three major areas: continued growth on AP test proficiency, English Learner attendance, and chronic absenteeism for all students. We also acknowledge that the effects of the pandemic will be significant and long-lasting. Additional Concentration Grant Funding

A description of the plan for how the additional concentration grant add-on funding identified above will be used to increase the number of staff providing direct services to students at schools that have a high concentration (above 55 percent) of foster youth, English learners, and low-income students, as applicable.

Our LEA has been using our Additional Concentration Grand funding to hire staff to provide direct services for our unduplicated student groups. Below we outline our efforts in regards to Free and Reduced Lunch, English Learners, and Foster Youth. Additional Concentration Grand funding supports increasing the number of credentialed staff to ensure that students receive personalized academic assistance to meet grade-level standards. These funds were also used to hire instructional staff trained to implement and support the i-Ready diagnostic and instructional program. These staff members provide direct services, ensuring personalized learning paths are effectively utilized. Schools demonstrating the greatest need for diagnostic assessments and personalized instruction received additional staff to maximize the impact of the i-Ready program. Funding supports the hiring of credentialed elective teachers to offer courses like Project Lead The Way (PLTW) and AEE, providing students with hands-on, project-based learning experiences in STEM and the arts. As we are continuing to push forward from the onset of the Covid-19 pandemic, we are focused on reducing Chronic Absenteeism rates, specifically for our unduplicated students. Funds are allocated to hire additional staff focused on reducing chronic absenteeism, utilizing programs like Everyday Labs and Attendance Works to engage with students and families directly. The grant funds are used to hire and support credentialed staff that manage and implement the Ellevation platform, providing targeted instructional strategies and support to English learners. Supporting Foster Youth and Homeless students is a high priority given our region’s area of need. This funding supports the hiring of additional credentialed staff to deliver a specialized advisory curriculum tailored to the needs of foster youth and homeless students, addressing their social-emotional and academic challenges. The grant funds additional staff to run Summer Bridge programs, assisting foster youth and homeless students in transitioning between grade levels or new schools with academic and social-emotional support. Funds are used to hire case managers and form partnerships with external mental health organizations, providing comprehensive mental health services to foster youth and homeless students.

Introduction and Instructions

For transparency, the functionality and calculations used are provided below.

Contributing Actions Table

- **4. Total Planned Contributing Expenditures (LCFF Funds)**
 - This amount is the total of the Planned Expenditures for Contributing Actions (LCFF Funds) column.
- **5. Total Planned Percentage of Improved Services**
 - This percentage is the total of the Planned Percentage of Improved Services column.
- **Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)**

- This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

Contributing Actions Annual Update Table

Pursuant to *EC* Section 42238.07(c)(2), if the Total Planned Contributing Expenditures (4) is less than the Estimated Actual LCFF Supplemental and Concentration Grants (6), the LEA is required to calculate the difference between the Total Planned Percentage of Improved Services (5) and the Total Estimated Actual Percentage of Improved Services (7). - **8. Total Estimated Actual Percentage of Improved Services (%)**

- This amount is the total of the Estimated Actual Percentage of Improved Services column.

- **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**

- This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

LCFF Carryover Table

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**

- This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**
 - If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.
- **13. LCFF Carryover — Percentage (12 divided by 9)**
 - This percentage is the unmet portion of the Percentage to Increase or Improve Services that the LEA must carry over into the coming LCAP year. The percentage is calculated by dividing the LCFF Carryover (12) by the LCFF Funding (9).
