

This chart shows the total general purpose revenue Ánimo Jefferson Charter Middle School expects to receive in the coming year from all sources.



# Increased or Improved Services for High Needs Students in the LCAP for the 2025-26 School Year


In 2025-26, Ánimo Jefferson Charter Middle School is projecting it will receive \$1,394,351 based on the enrollment of foster youth, English learner, and low-income students. Ánimo Jefferson Charter Middle School must describe how it intends to increase or improve services for high needs students in the LCAP. Ánimo Jefferson Charter Middle School plans to spend \$1,105,549 towards meeting this requirement, as described in the LCAP.

It is important to note that very nearly all enrolled students are socioeconomically disadvantaged (low income), meaning that nearly all planned and actual Goal Action expenditures inherently serve high needs students, regardless of being established as a targeted "Contributing Action". Additionally, the variance can be attributed to multiple external factors, including a challenging enrollment environment experienced by all LEAs in coastal Southern California and uncertainty in federal education policy and awarded funds. In 2025–26, as seen in each Goal section, to ensure compliance with the LCFF LCAP requirements to improve services for our high need students, the school is ensuring that general fund expenditures continue to directly support high needs students, strategically investing in targeted interventions, expanded

mental health supports, and academic acceleration initiatives.

Update on Increased or Improved Services for High Needs Students in 2024-25



This chart compares what Ánimo Jefferson Charter Middle School budgeted last year in the LCAP for actions and services that contribute to increasing or improving services for high needs students with what Ánimo Jefferson Charter Middle School estimates it has spent on actions and services that contribute to increasing or improving services for high needs students in the current year.

The text description of the above chart is as follows: In 2024-25, Ánimo Jefferson Charter Middle School's LCAP budgeted \$2,649,210 for planned actions to increase or improve services for high needs students. Ánimo Jefferson Charter Middle School actually spent \$\$2,634,927 for actions to increase or improve services for high needs students in 2024-25.

The difference between the budgeted and actual expenditures of \$14,283 had the following impact on Ánimo Jefferson Charter Middle School's ability to increase or improve services for high needs students:

While estimated actual expenditures were slightly less than budgeted, the school successfully implemented all planned actions and services for high needs students. It is important to note that nearly all enrolled students are socioeconomically disadvantaged (low income), meaning that all planned and actual Goal Action expenditures inherently serve high needs students, regardless of being established as a targeted ""Contributing Action". As such, despite the lower-than-anticipated estimated actuals, the school remained committed to maintaining the overall level of support, access, and quality of services intended to increase or improve outcomes for specific targeted student groups.

Moreover, the variance can be attributed to multiple external factors, including a challenging enrollment environment experienced by all LEAs in coastal Southern California, only modest increases in average daily attendance (ADA), and uncertainty in federal education policy and awarded funds. Consequently, the catastrophic fires in Los Angeles during the school year resulted in multiple days of closure, heavy pollution, and student and staff emotional distress; which resulted in a disruption of planned service delivery and implementation timelines.

# **Plan Summary [2025-26]**

### **General Information**

Ánimo Jefferson Charter Middle School ("JMS") is located in Los Angeles, California, more specifically Historic South-Los Angeles. Jefferson serves the communities of Downtown, Vernon, and Central Alameda. In 2018, the L.A. Department of City Planning estimated the population of the neighborhood to be 45,696, with roughly 18,760 people per square mile. In terms of education, 2.8% of residents that are 25 and older have a four-year degree, and 75% of residents in that age range failed to complete high school, which is the highest percentage of any Los Angeles City neighborhood. In regards to immigration and ancestry, 56.3% of residents are foreign born, mostly from Mexico and El Salvador. Ánimo Jefferson is a Title I school, meaning that more than half of our students are considered to be low-income. Our school receives funds that must be used to improve academic performance in all core academic subjects in order to close the achievement gap between low income students and other students. The funds can also be used to provide professional development for teachers, enhance parent involvement, improve curriculum, and support the implementation of other initiatives that will help raise student achievement. JMS's school population is composed of 427 students with a subgroup composition of 96.5% Latino, 21.6% English Learners, 12.9% Students with Disabilities, and 96.5% Socioeconomically Disadvantaged.

### **Reflections: Annual Performance**

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

Animo Jefferson continues to focus on growing our students to close the gap on grade level achievement. Our i-ready and MAP data indicates that our students in 6th and 8th grade are meeting their growth goals, however our 7th grade cohort continues to struggle to make

gains. The performance gap in English Language Arts (ELA), as indicated by a -56.6 DFS at Animo Jefferson, which is much lower than the state's average of -13.2 DFS, suggests there are both systemic and instructional challenges contributing to the decline. Several key areas that may be impacting student outcomes including Curriculum Alignment and Implementation and Data Utilization in planning.

While Animo Jefferson has continued to implement the My Perspectives curriculum across all core English classes, ensuring standards alignment, gaps in consistent and effective implementation could be a factor. Additionally, Animo Jefferson adopted the NWEA MAP Growth assessment to track students' progress and provide adaptive learning pathways, the impact of this tool on daily instructional practices may not be fully realized. Data from MAP Growth, when used in department meetings and parent conferences, is a step in the right direction, but more could be done to analyze and act upon data in real time to inform differentiated instruction and intervention needs.

Animo Jefferson has taken several measures this year to address these performance challenges, which focus on targeted interventions, improving curriculum implementation, and leveraging data to inform instruction. Primarily, professional development and coaching has been focused on curriculum, summative assessments, and pacing plans. This PD is essential for keeping teachers aligned and informed about best practices in literacy instruction. Additionally, the school has a Literacy Curriculum Specialist who offers targeted coaching and support to ELA teachers, which helps improve instructional strategies and student outcomes.

Our data also indicates that we need to provide additional support to our Emergent Bilingual (EB) students, Saturday workshops led by the English Department Chair provide additional instruction, focusing on language development and literacy. Additionally, the creation of specialized Empowered Reading classrooms for EB students, where they receive language instruction tailored to their needs, is an important step in narrowing the gap. Co-taught classes, special education aides, and small group instruction in Academic Success courses continue to provide individualized support for students with disabilities.

By continuing to refine these systems and strategies, Animo Jefferson is positioned to make significant strides in improving ELA performance, particularly for numerically significant student groups performing below state averages. With a focus on targeted interventions, culturally relevant materials, and ongoing data use, the school aims to close the achievement gap and improve literacy outcomes for all students.

In analyzing our Dashboard for Math performance we see a decline in Math performance we attribute to several factors including 1) instructional gaps in students, 2) variability in implementation amongst teachers, and 3) higher needs demonstrated amongst our subgroups. Students have experienced foundational gaps in math skills, impacting their ability to grasp grade-level concepts. And residual learning loss from previous years may continue to affect student performance. While Animo Jefferson has continued to implement the Illustrative Math curriculum across all core Math classes, ensuring standards alignment, gaps in consistent and effective implementation could be a factor. Variability in how well this curriculum is executed across different classrooms or grade levels may result in uneven outcomes. Additionally, although the i-ready program is used with fidelity for intervention classes- these programs require ongoing adjustments and teacher expertise to be most effective, especially for struggling students such as our significant subgroups. English Learners, students with disabilities, and socioeconomically disadvantaged students may require more specialized and individualized support.

To address these challenges, Ánimo Jefferson has implemented several key initiatives: 1) Continued Use of Standards-Aligned Curriculum; 2) Intervention and Enrichment Programs; and 3) Targeted Support for Numerically Significant Student Groups

Animo Jefferson continues to implement Illustrative Math curriculum across all core Math classes to ensure alignment with grade-level standards. Additionally, the i-Ready program and curriculum used in foundational math courses to reinforce essential skills. Teachers receive district-wide Professional Development focused on instruction & curriculum use. Regular assessment of student progress to tailor

interventions and instructional strategies. To strengthen our incoming student's foundational knowledge a High-Impact Tutor (HIT) placed in sixth-grade intervention classes for intensified small-group support. And for students who need more support to access core curriculum Co-Taught Core Math and Resource Classes (Academic Success) provide individualized instruction for students with disabilities.

Lastly, we are excited to offer opportunities for students who are approaching grade level or on-grade level to keep them growing in math. We are offering the Jaime Escalante Math Program (in partnership with East Los Angeles College) which provides additional instruction in math subjects. And during the school day we offer Project Lead the Way (PLTW) Courses offered for students demonstrating math proficiency. These initiatives aim to strengthen math instruction, close achievement gaps, and support all students—especially those performing below state averages.

The 2024 CA Dashboard indicates that overall, student progress at Animo Jefferson dropped by 8.3 points overall in Math and to a drop in our CA Dashboard indicator from Orange in 2023 to Red Indicator in 2024. For students with disabilities our dashboard data indicates that they dropped an overall 10.2 points which is nearly 2 points lower than their typical peers. Animo Jefferson has implemented multiple strategies to support Student with Disabilities (SWD) to achieve at least one performance level growth in math throughout the 2024-2025 school year. Co-taught classes are offered at all grade levels allowing students to receive instruction from both general education and special education teachers. All core classes use the Illustrative Math curriculum to ensure standards aligned instruction and teachers are given multiple planning days throughout the year to prepare lessons, accommodate assessments, and review data. The Academic Success course is a resource class where students with disabilities are able to receive small group instruction to meet individualized IEP goals and grade level standards. Resource teachers receive coaching from curriculum specialists, program administrators, and psychologists to closely monitor student progress and implement interventions.

The California Dashboard shows that Animo Jefferson was in the "red" performance level for "English Learners" in ELA as measured by CAASPP (SBAC) Assessment during the 2023-2024 school year. English Language learners dropped an additional 2 points in the 2024 SBAC and remain in the red performance level. Animo Jefferson has implemented multiple strategies to support English Learners in achieving at least one performance level growth in ELA throughout the 2024-2025 school year. The school is using the My Perspectives curriculum in all core classes and has multiple intervention programs such as Read 180 and K-12 Summit to support instruction. Designated ELD courses are offered at all grade levels to ensure all English Learners receive the appropriate language support. Animo Jefferson has also established Empowered Reading classrooms where EL students receive specialized language instruction. Extension Programs, on Saturdays and during school breaks, are also offered to provide additional language instruction and ELPAC test preparation. To involve parents in this process, our DELAC team has worked closely with stakeholders to provide information sessions where parents are able to learn about their children's data and the EL process (reclassification, integrated and designated supports, and the components of the ELPAC). To support its teachers, we have an assigned a Literacy Curriculum Specialist to help coach and support ELA teachers with data driven instruction and effective teacher strategies. The adoption of the NWEA Map Growth assessments, and continued use of Ellevation, also supports our ability to assess and track student progress.

In addition to the great work to address challenges, we also want to highlight successes and accomplishments. Over the course of two years the staff has been moving towards changing educational practices that are equitable and fair to the students. This school year we modified our grading system to better align to equitable grading practices by removing letter grades and replacing them with a 4 point scale. This change allows us to better assess and meet the needs of our students in order to support their academic growth. This grading modification aligns well with our practice of providing students multiple opportunities to demonstrate mastery. The second accomplishment was adding a

Measure of Academic Progress by administering the NWEA MAP test to all students. Students learned how to interpret their results and set goals in advisory classes. With this assessment change we also involved other key educational partners, parents. Our parent conferences held in September reviewed student results with parents and students and set growth goals for the second administration of the MAP test in December. Our parent conferences are now focused on growth and learning, a significant shift from previous years. Students, parents and teachers are using this information to focus on growth and learning.

Learning Recovery Emergency Block Grant (LREBG):

At the end of the 2024-25 school year, we had \$136,585 remaining of our Learning Recovery Emergency Block Grant. Aligning with LREBG allowable uses and to support our student needs to continue their growth in ELA and Mathematics, funds are supporting LCAP actions Goal 1 Action 1. This action supports the employment of ELA and Mathematics credentialed subject area teachers who have the skills and experience to support student academic outcomes, an identified student need as we work towards a Green and Blue indicator on the CA School Dashboard.

LCAP data is also reviewed quarterly during teacher conferences and professional development, and specifically Lexile and Quantile growth. We also review with our teachers indicators of SBAC readiness as it is a major component of our effort to monitor and improve outcomes for students here.
Principals	As mentioned in the row above, the principal leads and participates in SAC where they provide input and feedback on school outcomes and goals. Additionally, our principal leads coffee with principal, which is a space where parents are able to have open dialogue on student outcomes, school culture, and progress on school goals towards outcomes. Together in these spaces, we build relationships towards the process of developing our LCAP.
Administrators	Administrators actively participated as members of the School Advisory Council (""SAC""). The SAC is composed of the principal, administrators, teachers, classified staff members, parents and students. In these council meetings, they review school LCAP outcome data and goal progress throughout the school year. In the spring and early they provide feedback on updates we should make to our LCAP. Administrators that also serve our Emergent Bilinguals

	participate in the District English Learner Advisory Council. In this council, administrators provide feedback on the LCAP and its supports for English Learners, and also receive feedback from EL parents.
Other School Personnel	We engage many of our school personnel in the development of the LCAP throughout the school year. Our Parent Coordinator is part of DELAC where they give feedback on the LCAP and receive feedback from EL parents. Office administrators are part of our SAC where they review LCAP progress throughout the school year, and where they provide feedback on LCAP annual updates and the new 3-year cycle LCAP. These administrators also support with attendance and engaging with parents, and they provide a current pulse on school efforts.
Parents	Parents are key members of our SAC, and as mentioned above, we meet monthly to keep track of school outcome progress and our LCAP goals. This educational partner is key in understanding how to improve student outcomes for our students. Additionally, Emergent biligual parents are key members of DELAC, who also reviews and approves the LCAP through feedback and input. Our principal also provides spaces to engage parents more thoughtfully through our Coffee with Principal. In these meetings the principal works with parents on strategies and feedback on efforts to improve Attendance and academic achievement outcomes. This feedback is then used during the development process of the LCAP.
	Lastly, to ensure that we're soliciting all important educational partners for our LCAP feedback, we post on ParentSquare. ParentSquare is like a social media platform that empowers the school to reach all of our parents. We distributed our LCAP survey to all of our parents/guardians via ParentSquare and we were able to gather feedback from parents of Students with Disabilities, English Learners, and all parents/guardians of other numerically and non-numerically significant student groups. This is done to ensure we receive holistic stream of feedback and engagement of all families.
Students	Students are important members of our SAC Meetings as they provide key feedback and input on how to improve their peers' and

	own outcomes at the school. Additionally, I contribute to discussions by offering insights and weighing in on suggestions for school improvement, reinforcing our collective commitment to growth and excellence. They are part of the entire process throughout the school year of reviewing LCAP data, providing input and feedback, and voting to approve the LCAP in May.
	Green Dot Home Office works with school leaders to update the LCAP, analyzing data and monitoring progress toward goals. The LCAP is then presented to the School Advisory Council and the DELAC in May. These stakeholder groups provide feedback before the final SAC approval. The LCAP is then presented to the Green Dot Governing Board in June for final approval. Green Dot Public Schools CA, school leadership, and the SAC will all continue to monitor the school's progress toward these goals.
SELPA	Our SELPA is provided our LCAPs early in our process for review and feedback to ensure that we are providing the proper support, documentation, and explanation of the supports we provide our Students with Disabilities.

A description of how the adopted LCAP was influenced by the feedback provided by educational partners.

Since the onset of the current school year, we have begun the process of implementing and monitoring our plans and actions to support improved student and whole-school outcomes. This process launches with our first School Advisory Council ("SAC") and District English Learner Advisory Committee ("DELAC") meetings where we elect the members who will review and vote on our LCAPs. Throughout this school year, these members will review school and subgroup outcome data to monitor our progress for our Goals and the Actions that support them to ensure that equitable instructional support, resource allocation, familial governance, and related student progress is taking place across all student subgroups.

Additionally, the school community collectively is involved in and informed of our budgeting processes and practices to align student instructional and resource support with expressed needs. To ensure fidelity in our process and a high level of engagement from community members, the school distributes surveys to all students and families to help determine planned and actual expenditures. These figures are included in the final draft LCAP that our SAC and DELAC will review and vote on near the end of the school year. The process outlined above demonstrates our year-long commitment to developing LCAPs that reflect the interest and vision of our school community. This engagement included parents with limited English proficiencies, parents of English Learners, and parents of students with disabilities.

We also have Learning Recovery Emergency Block Grant ("LREBG") funds remaining for our school. During our budget development process, we host SAC and other budget specific meetings highlighting the current status of revenue, grant allocations, and the proposed

budget for the next school year. During these meetings we highlighted how we are using funds to support English Language Arts and Mathematics outcomes through programs, services, and staff members to target students needs.

# Goal Analysis [2024-25]

All actions were implemented as planned and there were no substantive differences. Goal #1 of the LCAP is to Provide Basic Services for All. This includes having appropriately Credentialed teachers in the subject areas, use of standards-aligned curriculum, and maintaining facilities in good repair.

Currently, 100% of JMS teachers are credentialed in the area they teach. Our students have access to a broad course of study in all grade levels. And all teachers have access to a standards aligned curriculum. We hope to maintain our teacher retention for the upcoming school year and continue their development of curriculum and instruction.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were no material differences between planned expenditures and estimated actual expenditures.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

As seen by our metric outcomes, all of our actions were effective in support our desired result. These actions will remain unchanged for this LCAP year, and will reassess next school year when working with educational partners. The action steps outlined in the LCAP have proven effective for Animo Jefferson in achieving 100% credentialed staff members for all students. Over the last 3 years as we have been working to fully staff all positions, Animo Jefferson has been working with Human Resources to ensure that throughout the year all credentials are properly maintained. Additionally, the principal collaborates with the Green Dot Human Resources Team to for mid- year hires and/or course changes for teachers throughout the year. Over the last three years of this LCAP cycle Animo Jefferson has been able to fully staff all vacancies and for the upcoming school year is anticipating retaining all hires. Our newer teachers are also receiving support in completing Clear Credential coursework in partnership with our curriculum specialists.

Goal # 2 Proficiency for All

We continue to use data to support students in preparation of the SBAC and ELPAC tests. While our goal to increase percent of EL students who reclassify as Fully English Proficient was not met last year, we did have an overall increase in ELPI of 55% outperforming the district and demonstrating that students are closer to reclassification.

Another area of growth continues to be increasing the percent of students scoring Met Standard and above on SBAC ELA, SBAC Math and CAST. To better support outcomes, we will continue to dedicate professional development time to breaking down standards and tasks to understand their rigor and alignment to grade level mastery.

There were no material differences between planned expenditures and estimated actual expenditures.

All actions were effective in supporting the results we were seeking. The opportunity is to continue the focus on further refining and perfecting action supports for outcome growth. Animo Jefferson will continue to dedicate professional development time to breaking down standards and tasks to understand their rigor and alignment to grade level mastery. While our teachers are using the curriculum with fidelity in classrooms we are seeing variability in implementation of lessons in the classroom.

To better support ELA outcomes, we have dedicated professional development time to breaking down standards and tasks to understand their rigor, Looking at or creating exemplars and conducting student work analysis to align on what mastery looks like, and determining how to re-teach or address gaps in understanding. Ensure in daily lesson planning that emergent bilingual students have an opportunity to engage in academic discourse with appropriate scaffolds. With these continued efforts and programs, we expect to see continued growth in our metric outcomes.

In addition to the academic meetings for all, our school counselor is a member of the school-site COST Team (Coordination of Services Team) which includes an Administrator, school psychologist, and a clinical or mental health supervisor that coordinates counseling and social- emotional services for students.

Chiefly, the school will maintain a high Average Daily Attendance ("ADA") rate greater than 90% and decrease student chronic absenteeism rate by 3% per year. Additionally, the school will decrease suspension rate by 3% per year and maintain an expulsion rate of 0.5% or less

Our current ADA is 92%, which is higher than our ADA rates for 2023-2024. Our COST team, Community Schools Coordinator, and EB team support with incentives, check ins, and data reviews of our ADA data. Additionally, we currently have a 0.2% suspension rate and a 0% expulsion rate.

As an area of growth, we are continuing to decrease our chronic absenteeism rates. We are currently at 26.4% and were at 27% last year.

To that end JMS needs to strengthen attendance monitoring, add student and family engagement initiatives, and continue to utilize the COST team for identification and resources that could minimize barriers to school attendance.

Our LEA has strategically invested Additional Concentration Grant funding to expand our team of highly qualified staff who deliver meaningful, student-centered services to our thriving unduplicated student populations. Below, we share how these investments are enhancing educational equity and opportunity for students eligible for Free and Reduced-Price Lunch, English Learners, and students in foster care. This funding has allowed us to increase the number of credentialed educators who provide personalized academic support, empowering students to meet and exceed grade-level expectations. We have also hired instructional staff who are expertly trained in

implementing the i-Ready diagnostic and instructional program. These educators design and facilitate individualized learning pathways that build on each student's strengths and ensure progress toward academic success. Schools demonstrating a strong opportunity for growth through diagnostic tools and tailored instruction received additional staff to maximize the benefits of the i-Ready program. Furthermore, grant funds support the hiring of credentialed elective teachers who engage students in enriching, project-based learning across STEM and the arts, helping students explore their interests and develop real-world skills. As part of our commitment to student well-being and engagement, we are prioritizing efforts to support consistent attendance. By investing in additional staff dedicated to attendance initiatives, and partnering with programs such as Everyday Labs and Attendance Works, we are creating stronger connections between school and home that support students' daily engagement and sense of belonging. To further elevate the success of our English Learners, we have dedicated grant funding to staff who implement the Ellevation platform, enabling educators to access targeted instructional strategies that affirm linguistic assets and accelerate language development. We recognize and honor the resilience and brilliance of our students in foster care and those experiencing homelessness. Our LEA uses grant funds to support additional credentialed staff who implement specialized advisory programs that address both the social-emotional and academic needs of these students. Summer Bridge programs, staffed with caring educators, offer transitional support that helps students build confidence and community as they move between grade levels or school sites. In addition, we have invested in hiring case managers and partnering with community-based mental health organizations to provide holistic, trauma-informed support, ensuring students have access to the resources they need to thrive both in and out of the classroom.

- Contributing to Increased or Improved Services?: Type "Yes" if the action is included as contributing to meeting the increased or improved services requirement; OR, type "No" if the action is **not** included as contributing to meeting the increased or improved services requirement.
- If "Yes" is entered into the Contributing column, then complete the following columns:
  - Scope: The scope of an action may be LEA-wide (i.e., districtwide, countywide, or charterwide), schoolwide, or limited. An action that is LEA-wide in scope upgrades the entire educational program of the LEA. An action that is schoolwide in scope upgrades the entire educational program of a single school.   - This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

 This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

  - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- 11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)
