




This chart shows the total general purpose revenue Ánimo Ralph Bunche Charter High School expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Ánimo Ralph Bunche Charter High School is \$12,084,633, of which \$8,831,466 is Local Control Funding Formula (LCFF), \$1,951,313 is other state funds, \$30,000 is local funds, and \$1,271,854 is federal funds. Of the \$8,831,466 in LCFF Funds, \$2,504,725 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).


All other funds that are not identified in the Local Control and Accountability Plan are allocated to personnel salaries and benefits and operational expenses such as rent, maintenance costs, debt service, material and supplies, furniture and fixtures, technology, legal services, janitorial services, security services, authorizer fees and other miscellaneous professional services.

Increased or Improved Services for High Needs Students in the LCAP for the 2024-25 School Year

In 2024-25, Ánimo Ralph Bunche Charter High School is projecting it will receive \$2,504,725 based on the enrollment of foster youth, English learner, and low-income students. Animo Ralph Bunche has implemented the action steps as planned and described in the LCAP. The principal works with human resources to ensure all teachers have a valid credential for the courses they teach. The school has adopted standards-based curriculum for Math and English and engages in regular walkthroughs, teacher coaching sessions, and professional development to support implementation.

The school ensures that students are provided and have access to the appropriate standards-aligned curricular materials as well as are assigned a Chromebook to facilitate access to the appropriate online resources.

The school regularly analyzes data to assess course progress and place students into appropriate classes for the upcoming school year and all students have access to the broad course of study.

The school conducts regular facilities walkthroughs and uses an online work order system to request and monitor maintenance or repairs. The school has secured sufficient furniture to provide a safe and comfortable learning environment.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

The original projected budget for the 2023-24 school year underestimated the salary ranges for teachers, school administrative staff, and new hires. The 2023-24 Actual Expenditures were higher than planned as the original budget did not account for a competitive market to retain and attract quality staff. This underestimation led to increased personnel costs in relation to salaries. Thus, resulting in material differences between planned and actual expenditures.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

ARB has been successful in implementing the actions steps to meet this goal and were effective in supporting our LCAP goal metrics. The school will continue to be intentional in working with Human Resources to ensure that all teachers have the proper credentials; the Education Team to ensure that students have access to the broad course of study and appropriate materials; and Facilities to ensure the building is in exemplary condition for learning.

An analysis of how this goal was carried out in the previous year. A description of any substantive differences in planned actions and actual implementation of these actions.

Although these areas continue to be a focus and action steps will continue to be implemented and monitored, ARB has made gains and met the following goals: 2a - SBAC ELA, 2d - EL Reclassification, 2d - EL Reclassification, 2e - ELPI Levels, 2f - CORE SGP ELA, and 2g - CORE SGP Math. The investment in EB Aides for each grade level to support EB scholars, the use of a standards-based curriculum for ELA, and the administration of math and ELA growth measure assessment will continue to be a focus to ensure future growth.

ARB will continue to be intentional in implementing action steps to ensure growth in 2b - SBAC Math and 2c - CAST. The school will continue to focus on providing teachers with professional development and coaching by their assigned administrator as well as their respective curriculum coach to internalize standards-based units, lessons, deconstruct grade-level standards, and implement benchmark assessments, followed by data analysis.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

The original projected budget for the 2023-24 school year underestimated the salary ranges for teachers, school administrative staff, and new hires. The 2023-24 Actual Expenditures were higher than planned as the original budget did not account for a competitive market to retain and attract quality staff. This underestimation led to increased personnel costs in relation to salaries. Thus, resulting in material differences between planned and actual expenditures.

As it relates to curriculum expenditures, more funds were spent on enhancing the curriculum through arts and music block grants. Our investment with this grant funding provided an enriched educational experience that is the root of material differences between actual expenditures compared to planned.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

Because the school has met the following goals: 2a - SBAC ELA, 2d - EL Reclassification, 2d - EL Reclassification, 2e - ELPI Levels, 2f - CORE SGP ELA, and 2g - CORE SGP Math, it is considered that the action steps related to these areas have been effective.

In terms of SBAC Math and CAST, the implementation of the action steps has not, yet, yielded the desired outcomes, and the school will continue to delve into the supports previously stated to facilitate growth in these areas. As we move into this next 3-year LCAP cycle we will continue to refine the implementation of our actions to ensure full effectiveness to continue our growth to meeting and exceeding our LCAP metrics goals.

Entering the new 3-year LCAP cycle that begins with the 2024-25 LCAP, we have focused and refined the language in our actions to reflect the efforts and vision for the next 3 years. Additionally, we have added a new Action specifically addressing our whole-school red indicator mathematics outcomes on the 2023 CA School Dashboard.

During the 2022-23 school year, our school did not have any substantive differences between our planned actions and the implementation of the actions. There were challenges in the implementation of our action related to Test Preparation. Staffing issues and challenges led to a lack in meeting with teachers consistently. Not all teachers participated in our mock exams due to these staff issues.

To rectify these issues and challenges, this current school year we have worked on training and supporting by giving extra time on Saturdays for students to test prep for Math and ELA SBAC assessments. In ELA and math courses, having intention in running weekend mock SBAC exams to better target gaps in learning that specific students have. We are working with our 11th grade instructional team on PD and pullouts to better support growth in ELA and math. Additionally, we are adding additional AP courses to further bolster our work and improve outcomes in this area.

The original projected budget for the 2023-24 school year underestimated the salary ranges for teachers, school administrative staff, and new hires. This underestimation led to increased personnel costs in relation to salaries. Thus, resulting in material differences between planned and actual expenditures.

As mentioned above, our implementation of action 3.4 met challenges and issues related to staffing in the 2022-23 school year. Once we're able to perfectly implement this action with the preparation of our staff we'll see the effectiveness of our actions in our metric outcomes. We have had great success in previous school years and look forward to our improved outcomes.

Plan Summary [2024-25]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

Ánimo Ralph Bunche Charter High School (ARB) is a public charter school located in the 90011 zip code of South Los Angeles. The surrounding neighborhood is known for a variety of factors: dense population, high-poverty, low income jobs, multiple factories, and an increasing homeless population.

ARB opened in 2006 as one of five Green Dot Public Schools high schools known as the Jefferson Transformation Project. The intention of this project was to significantly improve education outcomes for students in this part of the city. Jefferson High School (a Los Angeles Unified School District school located only a few blocks from ARB) has a history of significant drop out rates. Our namesake, Dr. Ralph Bunche, was a graduate of Jefferson High School and we are proud to honor his legacy by serving students from his home community. Our school model is built around the fundamental philosophy that small schools can offer the supportive environment needed to help students overcome barriers to education. Our grades 9-12 high school has approximately 558 students enrolled each year, with a range of 125-145 students in each grade. Our first graduating class was the Class of 2010 and since then we have celebrated a total of twelve graduating classes. ARB is one of the 18 public charter schools operated by Green Dot Public Schools California. We currently serve approximately 558 students, 99% of which are Latinos and 1% African American students. ARB is open to all students, including students with special needs and English Learners. 12.4% of our current school population are identified as students with special needs. Our current population of English Learners is 15.6%. The families that send their students to ARB struggle economically with 95.7% of our students classifying as socioeconomically disadvantaged.

One of the key components of ARB's model is a strong advisory program. Students meet with their advisory class every day for 40 minutes. Teachers serve as advisors and loop with their students each year, meaning a 9th grade advisor has the opportunity to advise their class for four years and see them graduate. This environment creates a family-like environment where students are supported and encouraged to do their best academically. Advisors are able to employ a variety of curriculum, such as Get Focused Stay Focused (career readiness) and lessons based on social emotional learning such as empathy. Advisory culminates each year with a grade level portfolio and at the end of the four year portfolio, there is a Senior Presentation and exit interview where students reflect on their growth over their four years at ARB. This powerful experience is a flagship aspect of the school culture.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

Animo Ralph Bunche Charter High School (ARB) continues to intentionally support scholars' outcomes, including significant subgroups, with well-rounded services to address learning loss experienced during the Pandemic. ARB has been successful maintaining low suspension rates, earning a 5 (blue) on the Dashboard, thanks to the approach taken with alternatives to suspension and restorative discipline. ARB also has demonstrated growth in the English Language Progress Indicator (ELPI), earning a 4 (green) on the Dashboard. This growth has been possible by the school investing in Emergent Bilingual (EB) Aides per grade level and students enrolled in designated courses to support language acquisition.

A continued focus at ARB regarding academics is in the areas of Math (1) and ELA (3). The school is investing in instructional coaching for the leadership team to support teachers, via coaching, in the implementation of grade-level, standards-based instruction across the content areas. This support also focuses on differentiation for significant subgroups.

Additionally, ARB is working on increasing Graduation rates (3) and CCI (3). In SY24, the school has invested in a third academic counselor and a College Success Advisor to work with all scholars and ensure they receive the support they need to earn A-G credits, thus being eligible to not only graduate with an A-G diploma, but also be eligible to apply to four-year universities.

Animo Ralph Bunche Charter High School is committed to improving the outcome of all students in Math. We received a red indicator on Mathematics for whole-school outcomes and a red indicator for our Hispanic and Socioeconomically Disadvantaged student groups. These are steps the school has taken to continue to improve outcomes for all students:

In September 2023, ARB established a partnership with Lavinia Group (LG), an outside consulting group whose mission is to support teachers and leaders to create equitable opportunities for all students. ARB's work with one of the LG consultants is to focus on the Math department. This focus is in alignment to the school improvement plan and goals to improve teacher planning and delivery of instruction by:

Engaging in collaborative intellectual preparation sessions of assessment and lesson materials to ensure clarity on what student mastery means,

Creating walkthrough and observation templates and tools to collect data over time to bring to Instructional Leadership meetings and support with Professional Development planning,

Observing and debriefing instruction with school leaders to calibrate on teacher areas of strength, opportunities for improvement, and planning next steps for both admin and teacher,

Analyzing trends reflected in multiple data sources (i.e.-student work, teacher planning materials) and planning for next steps as a result of those trends,

Creating progress monitoring tools to collect data to determine next steps in addressing gaps, and

Monitoring and supporting implementation of chosen GD curricula, where applicable

Another area of focus with LG is on SBAC support for all students, including:

Collaborating with the Math Curriculum Specialists (CS) in support of reaching SBAC goals through the teachers with whom they work Creating opportunities for student at bats with SBAC content and most needed test-taking skills/strategies

Instructional Coaching for Math Teachers

School Leaders meets with the Math CS bi-monthly to gain clarity of all the Green Dot resources available and initiatives to support teacher instruction. School Leaders and CS conduct bi-monthly walkthroughs to gain insight into trends in the facilitation of instruction across the department and align on coaching focus. Walkthrough data is also shared with the Math department head to support in monthly department meetings and check ins. The Math CS also collaborates with Lavinia Group to ensure that all supports of teachers and school leaders are aligned.

The Math department has engaged in instructional pull outs once per semester that are supported and guided by the Math CS. During pull out days, the teachers engage in Intellectual Prep and review upcoming units and assessments.

Quarterly Student Work Analysis with Math Curriculum Specialist: Teachers engage in student work analysis by identifying key standards and understanding what students need to know conceptually and show procedurally to demonstrate mastery, and plan reteach opportunities to address the gaps in upcoming lessons. Strategic Focus on SBAC

The 11th grade math teacher engaged in a pull out day with the Math CS to review the components of the SBAC and explored ways to improve student performance through both soft skills and reviewing content skills. The teacher mapped out their second semester instructional plan and created a daily SBAC review routine with SBAC released questions. The teacher also planned for an IAB on the CAASPP website and practice Performance Task on Mastery Connect. Additionally, the teacher engaged in intellectual preparation with the practice performance task by reviewing the rubric for SBAC and planned for anticipated misconceptions, made plans to provide more opportunities for students to write explanations and reasoning in upcoming lessons to support conceptual understanding.

ARB staff has participated in professional development to increase their understanding and knowledge of skills needed for students to be successful on the SBAC. Teachers are focusing on teaching students how to unpack a prompt or question via Three Reads. Increase in data driven support

The Math Department is shifting to the use of Mastery Connect to support students with SBAC testing and allow for teacher data analysis. There is a new initiative for all core math courses to administer unit assessments on Mastery Connect. The Mastery Connect platform supports students with developing skills for online testing by utilizing the same online tools and question types as the SBAC. Mastery Connect allows teachers to engage in data analysis at the item level, standard level, special subgroups, and class comparison. To support teachers with analysis, teachers will engage in two separate data analysis opportunities during department time in Semester 2 where they will identify key standards, performance of students, including subgroups, on the key standards, and identify trends and gaps. Teachers will then create a reteach plan to address the gaps in upcoming lessons. Teachers administer the iReady diagnostic for all students at the beginning, middle, and end of year. Teachers use the beginning of year data to identify existing gaps and plan for supports in their lessons. After the midyear iReady administration, teachers are able to identify students who have demonstrated growth and students who are not yet showing sufficient progress towards reaching their typical goal by the end of the year. Teachers use the midyear data to continue identifying gaps and plan for supports in their lessons for the second semester. Strategic Focus on SBAC

The 11th grade team has planned various opportunities for not only exposing students to become familiar with the SBAC, but also to double down and be able to support the students who are approaching proficiency. Just like in ELA, the bubble students in Math will participate in the Rising Stallion Workshops after Spring Break.

Animo Ralph Bunche Charter High School is committed to improving the outcome of student subgroups in Math. These are steps the school has taken to continue to improve outcomes for EBs and students with special needs (SpED):

Focus on Subgroups

Co-teaching in math was decided to increase the support of students with disabilities as well as support the needs of all students in the class. Subpopulations are able to receive additional support having two credentialed teachers in the room. In addition, the co-teachers also receive quarterly pull outs led by Home Office SPED Support who focus on planning lessons that address the needs of all students in the class. In one of the planning meetings, the teachers get additional exposure and support around the SBAC. Teachers plan lessons with the SBAC outcomes in mind.

Increased number of Emergent Bilingual Instructional Aides (EB IA): This year we included an additional EB IAs to support the EB population, especially our Newcomer population. ARB now has one EB Instructional Alde per grade level. There are additional office hours for Newcomers hosted by the EB IAs and one designated teacher.

Additional Concentration Grant Funding

A description of the plan for how the additional concentration grant add-on funding identified above will be used to increase the number of staff providing direct services to students at schools that have a high concentration (above 55 percent) of foster youth, English learners, and low-income students, as applicable.

Our LEA has been using our Additional Concentration Grand funding to hire staff to provide direct services for our unduplicated student groups. Below we outline our efforts in regards to Free and Reduced Lunch, English Learners, and Foster Youth. Additional Concentration Grand funding supports increasing the number of credentialed staff to ensure that students receive personalized academic assistance to meet grade-level standards. These funds were also used to hire instructional staff trained to implement and support the i-Ready diagnostic and instructional program. These staff members provide direct services, ensuring personalized learning paths are effectively utilized. Schools demonstrating the greatest need for diagnostic assessments and personalized instruction received additional staff to maximize the impact of the i-Ready program. Funding supports the hiring of credentialed elective teachers to offer courses like Project Lead The Way (PLTW) and AEE, providing students with hands-on, project-based learning experiences in STEM and the arts. As we are continuing to push forward from the onset of the Covid-19 pandemic, we are focused on reducing Chronic Absenteeism rates, specifically for our unduplicated students. Funds are allocated to hire additional staff focused on reducing chronic absenteeism, utilizing programs like Everyday Labs and Attendance Works to engage with students and families directly. The grant funds are used to hire and support credentialed staff that manage and implement the Ellevation platform, providing targeted instructional strategies and support to English learners. Supporting Foster Youth and Homeless students is a high priority given our region's area of need. This funding supports the hiring of additional credentialed staff to deliver a specialized advisory curriculum tailored to the needs of foster youth and homeless students, addressing their social-emotional and academic challenges. The grant funds additional staff to run Summer Bridge programs, assisting foster youth and homeless students in transitioning between grade levels or new schools with academic and social-emotional support. Funds are used to hire case managers and form partnerships with external mental health organizations, providing comprehensive mental health services to foster youth and homeless students.
