

This chart shows the total general purpose revenue Ánimo South Los Angeles Charter School expects to receive in the coming year from all sources.



Increased or Improved Services for High Needs Students in the LCAP for the 2025-26 School Year


In 2025-26, Ánimo South Los Angeles Charter School is projecting it will receive \$2,702,780 based on the enrollment of foster youth, English learner, and low-income students. Ánimo South Los Angeles Charter School must describe how it intends to increase or improve services for high needs students in the LCAP. Ánimo South Los Angeles Charter School plans to spend \$1,459,651 towards meeting this requirement, as described in the LCAP.

It is important to note that very nearly all enrolled students are socioeconomically disadvantaged (low income), meaning that nearly all planned and actual Goal Action expenditures inherently serve high needs students, regardless of being established as a targeted "Contributing Action". Additionally, the variance can be attributed to multiple external factors, including a challenging enrollment environment experienced by all LEAs in coastal Southern California and uncertainty in federal education policy and awarded funds. In 2025–26, as seen in each Goal section, to ensure compliance with the LCFF LCAP requirements to improve services for our high need students, the school is ensuring that general fund expenditures continue to directly support high needs students, strategically investing in targeted interventions, expanded

mental health supports, and academic acceleration initiatives.

Update on Increased or Improved Services for High Needs Students in 2024-25



This chart compares what Ánimo South Los Angeles Charter School budgeted last year in the LCAP for actions and services that contribute to increasing or improving services for high needs students with what Ánimo South Los Angeles Charter School estimates it has spent on actions and services that contribute to increasing or improving services for high needs students in the current year.

The text description of the above chart is as follows: In 2024-25, Ánimo South Los Angeles Charter School's LCAP budgeted \$3,798,906 for planned actions to increase or improve services for high needs students. Ánimo South Los Angeles Charter School actually spent \$\$3,491,591 for actions to increase or improve services for high needs students in 2024-25.

The difference between the budgeted and actual expenditures of \$307,315 had the following impact on Ánimo South Los Angeles Charter School's ability to increase or improve services for high needs students:

While estimated actual expenditures were slightly less than budgeted, the school successfully implemented all planned actions and services for high needs students. It is important to note that nearly all enrolled students are socioeconomically disadvantaged (low income), meaning that all planned and actual Goal Action expenditures inherently serve high needs students, regardless of being established as a targeted ""Contributing Action"". As such, despite the lower-than-anticipated estimated actuals, the school remained committed to maintaining the overall level of support, access, and quality of services intended to increase or improve outcomes for specific targeted student groups.

Moreover, the variance can be attributed to multiple external factors, including a challenging enrollment environment experienced by all LEAs in coastal Southern California, only modest increases in average daily attendance (ADA), and uncertainty in federal education policy and awarded funds. Consequently, the catastrophic fires in Los Angeles during the school year resulted in multiple days of closure, heavy pollution, and student and staff emotional distress; which resulted in a disruption of planned service delivery and implementation timelines.

General Information

Ánimo South Los Angeles (ASLA) is in its 18th year of operation and is governed by Green Dot Public Schools, one of the largest Charter. Management Organizations in California. The mission of Green Dot Public Schools is to change the landscape of public education in Los Angeles so that every child can receive a quality education that prepares them for college, leadership, and life. Green Dot opened its first start-up charter school in August 2000 in the Lennox community, named Ánimo Leadership Charter School. By 2006, Green Dot Public Schools opened seven additional charter schools; two of which were founded outside of Los Angeles- Ánimo Inglewood and Ánimo Venice. Additionally, Green Dot has taken on several transformation schools, including Ánimo Locke High School and Ánimo Legacy Middle School (formerly Phyllis Wheatley) with great success. All Green Dot Public Schools were named "Ánimo," a Spanish term meaning "vigor, mind, spirit, valor, effort, determination and the courage to overcome odds." Fueled by the high dropout rates within the surrounding area schools, ASLA started with a group of 140 9th graders and a staff of 7 teachers and 2 administrators who were committed to making a difference in the South Los Angeles community. ASLA opened its doors at the beginning of the 2004-2005 school year. It is located in South Los Angeles, near the unincorporated areas of Athens and Westmont in Los Angeles County. The community is north of the Century Freeway (105) and west of the Harbor (110) freeway. To the south is the city of Gardena, to the west is Hawthorne, and to the east is the community of Watts. The community that ASLA serves can also be described as a residential, urban, economically challenged area. This community experiences gang violence and crime. The estimated population is approximately 48,6060. In this zip code, the ethnic distribution is 60%. According to the United States Census Bureau, the most recent estimated population is approximately 48,606. In this zip code, the ethnic distribution is roughly 60% Latino and 37% Black with 25.3% of families living below the poverty line. Additionally, the median household income is \$44,670.

ASLA currently serves a student population of approximately 584 students in grades 9 -12, and many of our students are first- or second-generation college bound. Additionally, 97.1% of ASLA families are socioeconomically disadvantaged. Our student population is 80.5% Hispanic and 17.6% African-American.

LCAP SUCCESSES

LCFF Priority 4

Advanced Placement Test: Animo South Los Angeles Charter High School ("ASLA") experienced notable growth in our student's performance on Advanced Placement exams. During the 2023 - 2024 school year there were 119 unique students taking AP exams. Of those students 51% earned a 3 or higher on their respective AP test. This percentage is a decrease of 4% from prior year, however there are 2 notable areas of mention. The 2023 - 2024 school year was the first year that we offered AP Pre Calc as a course at ASLA and for the first round of testing 55% of the students enrolled passed with a 3 or higher. The second notable mention is that in our AP Spanish Language 96% of students passed with a 3 or higher and in our AP US History course 63% of students passed with a three or higher. In both courses our students out performed the global and state averages for these exams.

Reading Inventory: Our school continues to prioritize literacy, and internal data from our reading inventory shows positive progress. Specifically, the percentage of students meeting their individual growth goals increased from 62% to 65% compared to the previous year. In addition, 9th-grade students with disabilities (SWD) showed significant improvement, with the percentage exceeding their growth targets rising from 20% to 46%, a 26% increase. For our emerging bilingual (EB) students, there was a 24% increase in the overall number of EBs meeting their individual growth goals (from 38% to 62%). Most impressively, the percentage of 10th-grade EB students who exceeded their growth targets jumped from 14% to 57%. We look forward to continuing to grow key subgroups on our campus.

LCAP GROWTH AREAS

LCFF Priority 4:

MATH SBAC: During the SY23-24 school year, our Math SBAC data remained stagnant at 11% of students meeting or exceeding the standard. The school had demonstrated minimal growth in this area. However with the interventions and supports outlined in question 2a of this report, we are anticipating an improvement in our students' academic performance.

LCFF Priority 5 - Pupil Engagement:

ADA (Average Daily Attendance):

Since the pandemic, ASLA has seen a significant decrease in our average daily attendance (ADA), which has not yet returned to prepandemic levels. However, through a systematic approach that includes progress monitoring, attendance outreach, school-wide incentives, and parent workshops focused on improving attendance, we are starting to see a slight improvement. Currently, our ADA has increased from 90.3% in the 2023-24 school year to 91.3%. While this is a positive change, there is still considerable room for improvement, and maintaining a focus on attendance will remain a top priority.

Chronic Absenteeism:

During the 2023-24 school year, our chronic absenteeism rate decreased slightly from 32.8% to 32.3%. However, thanks to the efforts of our attendance team, our current Chronic Absenteeism (CAB) rate is 27.8%. If this trend continues, it will represent an improvement of nearly

5%. Despite this progress, we have not yet achieved the required 10% decrease year-over-year or met the state's goal of reducing chronic absenteeism to below 10%. Therefore, we will continue working closely with the Attendance Team, grade-level teams, counselors, and administrators to make further improvements in this area.

During the SY23-24 school year, our Math SBAC data remained stagnant at 11% of students meeting or exceeding the standard which demonstrates minimal growth in this area for the 2023-24SY. However, with the interventions and supports outlined in school professional development and lesson planning, students at ASLA performed below state averages in the 2023-24 school year in Math. The school is working to improve this data through various interventions within Math classrooms and outside of class support in Advisory and Saturday school. Currently, teachers are using data in their classes to respond to student needs through grade and curriculum appropriate interventions on a regular basis. For 9th graders, students are assigned individualized lessons in Math Foundations using the iReady platform to address their highest skill gaps. For 11th graders, teachers are engaging in regular data meetings with an administrator to determine reteaching opportunities and targeted support lessons for students to be successful on the SBAC exam. For the SDP Math teacher, the Math Curriculum Specialist has supported them in scaffolding the Math curriculum to ensure students are able to access rigorous grade level content. All Math teachers in collaboration with the Math Curriculum Specialist are using iReady data to implement targeted lessons in their Math classes based on skills that the majority of students struggled in. All Math teachers have also engaged in a gradebook analysis protocol with their administrative coach to identify specific students who need additional support in class.

In addition to in class support from teachers, specific subsets of students are engaging in Math intervention during Advisory time, and these students were chosen based on their performance on the iReady benchmark as well as Math grades. The 9th and 10th grade students engage in a Math intervention curriculum specifically designed to build basic Math skills so students can access grade level curriculum in class. The 11th grade specialized advisory is a group of students who according to iReady and class data are on the cusp of passing the SBAC exam. The 11th grade advisory focuses on exposing students to additional SBAC practice and addressing their specific skill gaps to prepare them for the exam. In the Spring, these 11th grade students will also engage in Saturday intervention programming to help prepare students for the upcoming SBAC exam.

Instructional Coaching:

Designated and integrated teachers are provided with ongoing feedback through coaching from the administrators and curriculum specialists. Coaching is focused on scaffolding instruction for Emergent Bilingual students, providing structured opportunities for discourse and explicit language instruction through a clear language criteria for success.

In addition to the great work being done to address challenges, we also want to highlight successes and accomplishments:

Since the beginning of the 2024-2025 school year, our school has made significant strides in both instructional accomplishments and cultural improvements, aligned with our school-wide theme, "Rooted in Unity, Together We Grow." Below are highlights of our accomplishments as well as a few learnings that have helped shape the path this year.

Greatest Accomplishments

Instruction:

One of our major achievements has been uniting the staff around a common purpose, focusing on collective growth and excellence. This alignment is supported by clear and measurable instructional goals that target the quality of instruction and student learning. Our instructional

focus this year is Academic Discourse and each of our sessions are focused on answering the following question: What are the best practices that will support my ability to engage in rigorous intellectual preparation, to support all students as constructors of knowledge (through speaking and writing) and to assess + respond to students' thinking aligned to standards mastery? And the goal for our instructional focus is to ensure that teachers are providing students with an opportunity to process what they are learning every 10 - 15 minutes through academic discussion. Based on data from our classroom walkthroughs we see that learnings from PD centered around discourse are being integrated into the classroom

We have expanded our academic offerings by adding two Advanced Placement (AP) courses—AP Computer Science and AP Calculus—providing students with greater opportunities to engage in college-level work. Additionally, we introduced two college courses on our campus - Administration of Justice and Psych 001- further enhancing the academic experience and preparing students for post-secondary success.

Culture:

In terms of culture, we've made strides in creating an environment that supports both students and staff. This year, we have established an electronics-free policy during instructional time, which has helped increase student focus and engagement. Students, teachers and parents report feeling as if the new policy has increased student engagement inside of classrooms.

The results of our Universal SEL (Social and Emotional Learning) Screener reflect that students are reporting higher levels of joy on campus, which speaks to the positive changes in our school environment.

Both students and staff have expressed an increased sense of safety, and we have seen fewer physical altercations as a result of our proactive approaches to conflict resolution.

We implemented systematic moments for staff joy, which is essential in preventing teacher burnout and fostering a positive, energized school culture. This initiative has been reinforced by the ongoing celebrations of student and cultural milestones, nearly on a weekly basis, further enhancing community engagement.

Parent involvement has been notably higher this year, with increased turnout at parent-teacher conferences, Back to School Night, and inperson "Coffee with the Principal" sessions.

Learning Recovery Emergency Block Grant (LREBG):

At the end of the 2024-25 school year, we had \$79,045 remaining of our Learning Recovery Emergency Block Grant. Aligning with LREBG allowable uses and to support our student needs to continue their growth in ELA and Mathematics, funds are supporting LCAP actions Goal 1 Action 1. This action supports the employment of ELA and Mathematics credentialed subject area teachers who have the skills and experience to support student academic outcomes, an identified student need as we work towards a Green and Blue indicator on the CA School Dashboard.

Teachers	Our Teachers are key pieces of our LCAP development process. They are active members in our School Advisory Council ("SAC"). Grade level leads are official committee members of the SAC. The SAC is composed of the principal, administrators, teachers, classified staff members, parents and students. Throughout the school year the SAC reviews LCAP data outcomes, progress on goals, and in the Spring, they provide feedback and input on our progress. At the end of the school year, they vote to approve the LCAP that is then sent to our governing board for final approval. Staff members prioritize providing academic support resources to students to help them succeed academically. Our LCAP is a yearlong process of analyzing data, providing input, and lastly approval before sending to our governing board for final approval.
Principals	The Principal leads and is a permanent member of our School Advisory Council ("SAC"). As mentioned in the Teacher row above, it is composed of a diverse set of educational partners who review, provide feedback/input, and approve our LCAPs. Our Principal leads these meetings where LCAP data and outcomes are discussed, and records this feedback for use during the development of the LCAP. Coffee with Principal is also a space led by our Principal where they facilitate discussion between parents and school community members on our LCAP data and progress.
Administrators	Teachers actively participated as members of the School Advisory Council ("SAC"). The SAC is composed of the principal, administrators, teachers, classified staff members, parents and

	students. In these council meetings, they review school LCAP outcome data and goal progress throughout the school year. In the spring and early they provide feedback on updates we should make to our LCAP. Administrators that also serve our Emergent Bilinguals participate in the District English Learner Advisory Committee. In this council, administrators provide feedback on the LCAP and its supports for English Learners, and also receive feedback from EL parents.
	In addition to these councils and committees, our administrators review LCAP school outcome data quarterly and during our instructional January retreats. They also review and track progress in department meetings, grade level team meetings, and ILT team meetings.
Other School Personnel	During the school year, the school uses several outreach strategies to engage with educational partners on the LCAP. The School Advisory Council ("SAC") has reviewed goals, outcomes data, and expenditures data at multiple points throughout the year. The SAC is composed of the principal, administrators, teachers, School Operations Manager, classified staff members, parents and students. Classified Staff members, leadership team members, and other are members of the SAC and have the opportunity to provide specific feedback on the various elements and identify areas of success and challenge to focus on in the coming year.
Parents	Parents are key members of our SAC, and as mentioned above, we meet monthly to keep track of school outcome progress and our LCAP goals. This educational partner is key in understanding how to improve student outcomes for our students. Additionally, Emergent biligual parents are key members of DELAC, who also reviews and approves the LCAP through feedback and input. Our principal also provides spaces to engage parents more thoughtfully through our Coffee with Principal. This feedback is then used during the development process of the LCAP.
	Lastly, to ensure that we're soliciting all important educational partners for our LCAP feedback, we post on ParentSquare.

	ParentSquare is like a social media platform that empowers the school to reach all of our parents. We distributed our LCAP survey to all of our parents/guardians via ParentSquare and we were able to gather feedback from parents of Students with Disabilities, English Learners, and all parents/guardians of other numerically and non-numerically significant student groups. This is done to ensure we receive holistic stream of feedback and engagement of all families.
Students	Students are important members of our SAC Meetings as they provide key feedback and input on how to improve their peers' and own outcomes at the school. Additionally, the principal contributes to discussions by offering insights and weighing in on suggestions for school improvement, reinforcing our collective commitment to growth and excellence. They are part of the entire process throughout the school year of reviewing LCAP data, providing input and feedback, and voting to approve the LCAP in May.
	Green Dot Home Office works with school leaders to update the LCAP, analyzing data and monitoring progress toward goals. The LCAP is then presented to the School Advisory Council and the DELAC in May. These stakeholder groups provide feedback before the final SAC approval. The LCAP is then presented to the Green Dot Governing Board in June for final approval. Green Dot Public Schools CA, school leadership, and the SAC will all continue to monitor the school's progress toward these goals.
SELPA	Our SELPA is provided our LCAPs early in our process for review and feedback to ensure that we are providing the proper support, documentation, and explanation of the supports we provide our Students with Disabilities.

A description of how the adopted LCAP was influenced by the feedback provided by educational partners.

The creation of the LCAP each year occurs simultaneously with budgeting, hiring, master scheduling, and strategic planning. Starting in December of each year, the School Advisory Council—which is made up of elected parents, students, faculty and staff—reviews any relevant progress made towards the LCAP of the current year. Throughout the school year, we receive feedback from our DELAC, SAC and Parent Principal Chats which influences the programs and resources that we prioritize for our students, families and staff. Most importantly, the feedback is used to reflect on our goals and identify the next steps needed to move closer to achieving them, it informs our budget priorities,

as well as professional development. This engagement included parents with limited English proficiencies, parents of English Learners, and parents of students with disabilities.

We also have Learning Recovery Emergency Block Grant ("LREBG") funds remaining for our school. During our budget development process, we host SAC and other budget specific meetings highlighting the current status of revenue, grant allocations, and the proposed budget for the next school year. During these meetings we highlighted how we are using funds to support English Language Arts and Mathematics outcomes through programs, services, and staff members to target students needs.

All actions were implemented as planned and there were no substantive differences. For this goal, we budgeted to make sure our teachers received support to have the appropriate credentials, and were enrolled in any induction programs as needed. We also offer a broad course of study for our students including AP courses, Dual Enrollment courses, PLTW courses, and various electives including Art and Environmental Science. Our building facilities are in good condition, and are maintained throughout the year.

As seen across all metrics in this goal, all of our Actions were successfully effective in supporting our desired result in metric outcomes across credentialed teachers, our Broad course of study to support students, and maintaining an exemplary facility for our students and school staff. These actions will remain unchanged for this LCAP year, and will reassess next school year when working with educational partners.

Goal Analysis [2024-25]

An analysis of how this goal was carried out in the previous year.

All actions were implemented as planned and there were no substantive differences. ELPI: We have required steps to support our English Learners and Long-Term English Learners, who we call Emergent Bilingual students. We're working to improve how we carry out parts of these steps, as shown in the planning below:

The 2024 California School Dashboard report on the school's performance on the English

Learner Progress Indicator shows that Animo South Los Angeles has earned a Status level of Red, which is lower than the State's Status level of Orange. The report shows that 36.7 percent of scholars are making progress towards English language proficiency which is lower than the State at 45.7 percent. Animo South Los Angeles saw a decline of 18.2 percent overall in our ELPI, indicating that we needed to refocus our efforts to support our English learners.

Language Support Classes

Given our ELPI results at the end of last school year, we have intensified support for Emergent Bilingual (EB) students through two primary methods: intensified support through instruction in both Designated and Integrated ELD, and implemented a student motivational campaign prior to the ELPAC. We have maintained our ELD-designated course structure to ensure that scholars receive the ELD support necessary, as well as a rigorous grade-level appropriate standards-based curriculum. During the 2023-2024 school year, we offered four designated ELD courses: Literacy Enrichment for 9th grade EB scholars, Academic English Essentials for 10th-grade EB scholars, Specialized advisory course for 11th grad EB scholars and New Comer EB scholars. These four courses allowed EB scholars to receive rigorous standard-based instruction with embedded ELD support. The teachers facilitating these classes worked closely with the content curriculum specialist in developing the lessons with intentional scaffolds to make the content accessible to all EB scholars.

Teacher Professional Development and Training

Beginning at the start of this school year, we met with Designated ELD teachers to provide training on a new ELPAC practice platform, Summit K12. This platform, along with targeted lessons to build English learner proficiency in listening, speaking, reading, and writing skills, has given our Designated teachers a new method to prepare students for the ELPAC. Since then, Designated teachers have made it part of their weekly routine to provide students with intensified ELPAC preparation in all Designated classrooms. Teachers met at the beginnin gof the Spring semester to reevaluate their ELPAC preparation strategies and use student ELPAC data to target their lessons to build skills in areas that English learners needed the most support. Through these supports, EB scholars had the opportunity for repeated practice on ELPAC-tested skills and were able to build confidence in navigating the testing platform.

Integrated ELD has become an important part of our Professional Development plans for the 2024-2025 SY. We began the year by providing all teachers the opportunity to review the specific supports required for every EB student on their rosters. Teachers were then asked to use this data to determine the most appropriate instructional support and assessment strategies for their EB students based on students current ELPAC performance levels. We also provided teachers with conversation strategies to encourage continuous academic discourse for EB scholars. These skills have been spiraled through our Academic Discourse PD series,

Lastly, we determined that student motivation is a possible factor in our ELPI score decrease. Our review of ELPAC score data indicated that we had approximately 30 EB scholars on the brink of receiving a 4 on the ELPAC or who missed their reclassification criteria RIT score by only a few points. With the support of a general education teacher, we were able to bring those students together to reflect on their current progress with ELPAC and MAP RIT scores and create goals for each scholar to achieve prior to ELPAC testing. We also recruited the support of general education teachers and instructional aides to create a motivational video for all EB students and hand-sign personalized cards for every student to read prior to the ELPAC. With all of these instructional and motivational supports, we expect to see improved results for all English learners on the ELPAC to obtain at least 10% growth in our ELPI metrics.

Math SBAC: We have required steps to support our math achievement data and we are working to improve how we carry out parts of these steps, as shown in the planning below:

Students at ASLA performed below state averages in the 2023-24 school year in Math. The school is working to respond to this data through various interventions within math classrooms and outside of class support in Advisory and Saturday school. Currently, teachers are using data in their classes to respond to student needs through grade and curriculum appropriate interventions on a regular basis. For 9th graders, students are assigned individualized lessons in Math Foundations using the iReady platform to address their highest skill gaps. For 11th graders, teachers are engaging in regular data meetings with an administrator to determine reteaching opportunities and targeted support

lessons for students to be successful on the SBAC exam. For SDP Math teacher, the Math Curriculum Specialist has supported the teacher in scaffolding the Math curriculum to ensure students are able to access rigorous grade level content. All Math teachers in collaboration with the Math Curriculum Specialist are using iReady data to implement targeted lessons in their math classes based on skills that the majority of students struggled in. All Math teachers have also engaged in a gradebook analysis protocol with their administrative coach to identify specific students who need additional support in class.

In addition to in class support from teachers, specific subsets of students are engaging in Math intervention during Advisory time. The students in these specialized advisories were chosen based on their performance on the iReady benchmark as well as Math grades. The 9th and 10th grade students engage in a Math intervention curriculum specifically designed to build basic math skills so students can access grade level curriculum in class. The 11th grade specialized advisory is a group of students who according to iReady and class data are on the cusp of passing the SBAC exam. The 11th grade advisory focuses on exposing students to additional SBAC practice and addressing their specific skill gaps to prepare them for the exam. In the Spring, the 11th grade students will also engage in Saturday intervention programming to help prepare students for the upcoming SBAC exam.

All actions were effective in supporting the results we were seeking. The opportunity is to continue the focus on further refining and perfecting action supports for outcome growth. Based on the data available from this specific goal, it is clear that we room for improvement in both out ELPI scores as well as our math achievement data. We continue to remain hopeful that through greater intentionality and consistent implementation of our action steps we will see a shift in our data for the better.

To better align with the intent behind our reported outcomes, we have updated the way we describe our expected outcomes. All actions were implemented as plan and there were no substantive differences between planning and implementation. To support the achievement of our overall school goals, several targeted action steps were implemented. In the area of A–G completion, where we achieved a 93.3% rate, we provided intentional academic counseling, course alignment, and strategic student supports to ensure students stayed on track for college eligibility. To maintain our strong 96% cohort graduation rate, we focused on early identification and intervention for at-risk students, expanded credit recovery options, and strengthened family engagement and participation in relation to academic requirement for students. Additionally, our AP pass rates and College/Career Indicator (CCI) scores surpassed set goals due to increased access to rigorous coursework, targeted AP tutoring and practice exams and preparation, and greater promotion of dual enrollment and CTE pathways for students. These efforts collectively reflect our commitment to academic excellence and student readiness.

All actions were implemented as planned and there were no substantive difference between planned actions and implementation. Average Daily Attendance:

Since the pandemic, ASLA has seen a significant decrease in our average daily attendance (ADA), which has not yet returned to prepandemic levels. However, through a systematic approach that includes progress monitoring, attendance outreach, school-wide incentives, and parent workshops focused on improving attendance, we are starting to see a slight improvement. Currently, our ADA has increased from 90.3% in the 2023-24 school year to 91.3%. While this is a positive change, there is still considerable room for improvement, and maintaining a focus on attendance will remain a top priority.

Chronic Absenteeism:

During the 2023-24 school year, our chronic absenteeism rate decreased slightly from 32.8% to 32.3%. However, thanks to the efforts of our attendance team, our current Chronic Absenteeism (CAB) rate is 27.8%. If this trend continues, it will represent an improvement of nearly 5%. Despite this progress, we have not yet achieved the required 10% decrease year-over-year or met the state's goal of reducing chronic absenteeism to below 10%. Therefore, we will continue working closely with the Attendance Team, grade-level teams, counselors, and administrators to make further improvements in this area.

There were no material differences between planned expenditures and estimated actual expenditures.

Our LEA has strategically invested Additional Concentration Grant funding to expand our team of highly qualified staff who deliver meaningful, student-centered services to our thriving unduplicated student populations. Below, we share how these investments are enhancing educational equity and opportunity for students eligible for Free and Reduced-Price Lunch, English Learners, and students in foster care. This funding has allowed us to increase the number of credentialed educators who provide personalized academic support. empowering students to meet and exceed grade-level expectations. We have also hired instructional staff who are expertly trained in implementing the i-Ready diagnostic and instructional program. These educators design and facilitate individualized learning pathways that build on each student's strengths and ensure progress toward academic success. Schools demonstrating a strong opportunity for growth through diagnostic tools and tailored instruction received additional staff to maximize the benefits of the i-Ready program. Furthermore, grant funds support the hiring of credentialed elective teachers who engage students in enriching, project-based learning across STEM and the arts, helping students explore their interests and develop real-world skills. As part of our commitment to student well-being and engagement, we are prioritizing efforts to support consistent attendance. By investing in additional staff dedicated to attendance initiatives, and partnering with programs such as Everyday Labs and Attendance Works, we are creating stronger connections between school and home that support students' daily engagement and sense of belonging. To further elevate the success of our English Learners, we have dedicated grant funding to staff who implement the Ellevation platform, enabling educators to access targeted instructional strategies that affirm linguistic assets and accelerate language development. We recognize and honor the resilience and brilliance of our students in foster care and those experiencing homelessness. Our LEA uses grant funds to support additional credentialed staff who implement specialized advisory programs that address both the social-emotional and academic needs of these students. Summer Bridge programs, staffed with caring educators, offer transitional support that helps students build confidence and community as they move between grade levels or school sites. In addition, we have invested in hiring case managers and partnering with community-based mental health organizations to provide holistic, trauma-informed support, ensuring students have access to the resources they need to thrive both in and out of the classroom.
