To ensure parents and family members are involved in the development of this LEA Plan and support and improvement plans, the school will include topics of discussion and opportunities for feedback in the SAC and DELAC meetings.

The SAC and DELAC meet regularly to review school data, discuss priorities, and contribute to decision-making. The composition of these committees ensure that at least 50% of representation includes parents and students and 51% or more representation of parents respectively.

Members provide input and contribute to the decision-making process, including voting on plans and procedures and providing feedback throughout the year.

Programs and local agencies such as Head Start and Department of Public Social Services will be in communication with the schools. Nominations may be made by other parents or parents may self nominate and go through the voting process to be elected. The LEA performs annual outreach to ensure these committees meet the composition requirements.
