

This chart shows the total general purpose revenue Ánimo Venice Charter High School expects to receive in the coming year from all sources.




# Increased or Improved Services for High Needs Students in the LCAP for the 2025-26 School Year

In 2025-26, Ánimo Venice Charter High School is projecting it will receive \$1,281,215 based on the enrollment of foster youth, English learner, and low-income students. Ánimo Venice Charter High School must describe how it intends to increase or improve services for high needs students in the LCAP. Ánimo Venice Charter High School plans to spend \$961,721 towards meeting this requirement, as described in the LCAP.

It is important to note that very nearly all enrolled students are socioeconomically disadvantaged (low income), meaning that nearly all planned and actual Goal Action expenditures inherently serve high needs students, regardless of being established as a targeted "Contributing Action". Additionally, the variance can be attributed to multiple external factors, including a challenging enrollment environment experienced by all LEAs in coastal Southern California and uncertainty in federal education policy and awarded funds. In 2025–26, as seen in each Goal section, to ensure compliance with the LCFF LCAP requirements to improve services for our high need students, the school is ensuring that general fund expenditures continue to directly support high needs students, strategically investing in targeted interventions, expanded mental health supports, and academic acceleration initiatives.

Update on Increased or Improved Services for High Needs Students in 2024-25



This chart compares what Ánimo Venice Charter High School budgeted last year in the LCAP for actions and services that contribute to increasing or improving services for high needs students with what Ánimo Venice Charter High School estimates it has spent on actions and services that contribute to increasing or improving services for high needs students in the current year.

The text description of the above chart is as follows: In 2024-25, Ánimo Venice Charter High School's LCAP budgeted \$2,897,891 for planned actions to increase or improve services for high needs students. Ánimo Venice Charter High School actually spent \$2,840,167 for actions to increase or improve services for high needs students in 2024-25.

The difference between the budgeted and actual expenditures of \$57,724 had the following impact on Ánimo Venice Charter High School's ability to increase or improve services for high needs students:

While estimated actual expenditures were slightly less than budgeted, the school successfully implemented all planned actions and services for high needs students. It is important to note that nearly all enrolled students are socioeconomically disadvantaged (low income), meaning that all planned and actual Goal Action expenditures inherently serve high needs students, regardless of being established as a targeted ""Contributing Action"". As such, despite the lower-than-anticipated estimated actuals, the school remained committed to maintaining the overall level of support, access, and quality of services intended to increase or improve outcomes for specific targeted student groups.

Moreover, the variance can be attributed to multiple external factors, including a challenging enrollment environment experienced by all LEAs in coastal Southern California, only modest increases in average daily attendance (ADA), and uncertainty in federal education policy and awarded funds. Consequently, the catastrophic fires in Los Angeles during the school year resulted in multiple days of closure, heavy pollution, and student and staff emotional distress; which resulted in a disruption of planned service delivery and implementation timelines.

# **Plan Summary [2025-26]**

#### **General Information**

Ánimo Venice Charter High School (AVCHS) opened in 2004 to provide an alternative public high school option to students living in Venice, Oakwood, and some of the surrounding communities of Mar Vista, Inglewood, Culver City, and West Los Angeles. Ánimo Venice currently serves 334 students in grades 9-12. The school is not only attended by students in the surrounding neighborhood but also attracts many students from Inglewood and other parts of Los Angeles. The school serves families from a wide cross-section of the racial, cultural, and socioeconomic spectrums. 91.9% of students are socio-economically disadvantaged. 88.9% of students are Latino, 6.3% are African American and 3.3% white students. 20.1% of our students have an IEP. Ánimo Venice serves 6.3% of AVCHS students who are currently classified as emerging bilinguals. Ánimo Venice is committed to preparing students for college, leadership and life. When students join Ánimo Venice, we commit to support all students at their present academic levels and to prepare them to take on any challenge they will meet after graduation. We work to ensure all students have the opportunity to go to a four year college. We want to see our students walk out with the skills, the grit and determination to take on the challenges of college, leadership and life and to be successful. Our mission is to ensure students are prepared to take on the college experience and are equipped to earn a degree. While at Ánimo Venice we will work to support our students in developing a love for learning, a habit of self-reflection, and an adopted value in caring about their community and others. We support all children in striving to be the best scholars and individuals possible, honoring self, family and community.

### **Reflections: Annual Performance**

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

Our school's 2024 CA School Dashboard Status in Math is -118.1 DFS, which is lower than the state average of -47.6 DFS. We've identified a root cause analysis and are implementing strategies and programs to improve student outcomes in Math.

Similar to recent years, the root causes for lower math performance (-118.1 DFS, Orange performance level) include scholars entering below grade level and lacking support services. To address this, AVCHS engaged in a Math Team Summit during the summer to ensure vertical alignment and analyze data to reveal standards with which scholars struggle most. In addition, our matrix has been adjusted so that our most experienced math teachers teach intervention courses, and we have implemented a 12-week math intervention program for our 11th-grade scholars, which allows for focused math instruction and support during the morning College Readiness period. This support has not only been given to scholars "on the bubble" or nearing proficiency but has been extended to all 11th-grade scholars. We have closely partnered with our district curriculum specialist team to ensure that teachers can access prepared and vetted math resources to support learning and provide practice. Differentiated instruction continues in our Math Foundations and Academic Success courses to ensure that scholars receive the support and academic scaffolding necessary to succeed.

These efforts aim to improve math outcomes for all scholars, including Latino and Socioeconomically Disadvantaged groups, aligning with AVCHS's commitment to equity and excellence.

Our school's 2024 CA School Dashboard College/Career percentage is lower than the state, and all of the school's numerically significant student groups have a College/Career percentage lower than the state's percentage for those student groups.

To enhance College/Career readiness, the school has:

- Increased access to college and career guidance services via a site-based College Success Advisor and partnership with UCLA's Early Academic Outreach Program (EAOP).
- Expanded College Readiness curriculum to cover SAT/ACT prep, completion of college applications, completion of the FAFSA, participation in college and career presentations, CCGI, and study skills in all four grade levels.
- Dual Enrollment: Offering opportunities for scholars in grades 9-12 to earn college credits through West Los Angeles College.
- Increased resources for college visits and fee waivers for all scholars. This includes East Coast, West Coast, NorCal, local, and HBCU college trips.

These strategies aim to bridge the College/Career readiness gap, particularly for underrepresented groups like Latino and Socioeconomically Disadvantaged scholars, aligning with the school's equity-focused approach.

In addition to the great work being done to address challenges, we also want to highlight successes and accomplishments. Expansion of dual enrollment in partnership with West Los Angeles College to include participation opportunities for students in grades 9-12. Engagement of additional teacher-led supports for academic achievement, including but not limited to: Mock Advanced Placement (AP) Testing program every Saturday in March; Targeted Advisory intervention for 11th grade SBAC math achievement; Mock ELA SBAC with data analysis pull out for administering teachers. Nearly 40% of the student population participates in one or more competitive CIF sports teams, which include boys' and girls' basketball, boys' and girls' volleyball, boys' and girls' soccer, boys' and girls' golf, boys' and girls' badminton, softball, and

baseball. Use of Community Schools Grant funds to support college knowledge and exposure via tours for every grade level and partnership with What's Your Cause (WYC) for career exposure and motivation for the entire student body.

Learning Recovery Emergency Block Grant (LREBG):

At the end of the 2024-25 school year, we had \$81,000 remaining of our Learning Recovery Emergency Block Grant. Aligning with LREBG allowable uses and to support our student needs to continue their growth in ELA and Mathematics, funds are supporting LCAP actions Goal 1 Action 1. This action supports the employment of ELA and Mathematics credentialed subject area teachers who have the skills and experience to support student academic outcomes, an identified student need as we work towards a Green and Blue indicator on the CA School Dashboard.

We distributed our LCAP survey to all of our parents/guardians via ParentSquare and we were able to gather feedback from parents of Students with Disabilities, English Learners, and all parents/guardians of other numerically and nonnumerically significant student groups. This is done to ensure we receive holistic stream of feedback and engagement of all families.
Students	Students are important members of our SAC Meetings as they provide key feedback and input on how to improve their peers' and own outcomes at the school. Additionally, I contribute to discussions by offering insights and weighing in on suggestions for school improvement, reinforcing our collective commitment to growth and excellence. They are part of the entire process throughout the school year of reviewing LCAP data, providing input and feedback, and voting to approve the LCAP in May.  Green Dot Home Office works with school leaders to update the LCAP, analyzing data and monitoring progress toward goals. The

	LCAP is then presented to the School Advisory Council and the DELAC in May. These stakeholder groups provide feedback before the final SAC approval. The LCAP is then presented to the Green Dot Governing Board in June for final approval. Green Dot Public Schools CA, school leadership, and the SAC will all continue to monitor the school's progress toward these goals.
SELPA	Our SELPA is provided our LCAPs early in our process for review and feedback to ensure that we are providing the proper support, documentation, and explanation of the supports we provide our Students with Disabilities.

The school actively engages in a process of collecting and processing feedback through presentations, conversations, and analysis of survey data from all stakeholders including students, teachers, non-instructional staff, parents, and administrators. These methods are used formulate goals and initiatives. We have worked to create opportunities for all Educational Partners to contribute to developing the LCAP in both formal and informal ways. Formally, feedback and suggestions are received in School Advisory Council (SAC) meetings, DELAC meetings, Coffee With The Principal, Staff meetings, and via a multitude of varietal surveys. This engagement included parents with limited English proficiencies, parents of English Learners, and parents of students with disabilities.

We also have Learning Recovery Emergency Block Grant ("LREBG") funds remaining for our school. During our budget development process, we host SAC and other budget specific meetings highlighting the current status of revenue, grant allocations, and the proposed budget for the next school year. During these meetings we highlighted how we are using funds to support English Language Arts and Mathematics outcomes through programs, services, and staff members to target students needs.

# Goal Analysis [2024-25]

An analysis of how this goal was carried out in the previous year.

All actions were implemented as planned and there were no substantive differences. The listed actions were implemented overall as articulated. Strategically, throughout the school year, all necessary meetings for planning, implementation, and data review were held.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Material differences between planned expenditures versus estimated actuals can be attributed to multiple external factors, including a challenging enrollment environment, only modest increases in average daily attendance (ADA), and uncertainty in federal education policy and awarded funds. Consequently, the catastrophic fires in Los Angeles during the school year resulted in multiple days of closure, heavy pollution, and student and staff emotional distress; which resulted in a disruption of planned service delivery and implementation timelines.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

All actions were effective in supporting the results we were seeking. The opportunity is to continue the focus on further refining and perfecting action supports for outcome growth. All curricula have been implemented effectively in accordance with the list of actions. The support provided to EL students has been highly effective based on progress on the ELPAC and grade data that suggests that students are improving academically. Regarding special education, the initiatives listed have been effective, as shown by students' progress with IEPs. While students with IEPs may progress slower, it is still clear, based on the data review, that progress is being made. High-achieving students have access to AP courses and dual enrollment opportunities. A professional development plan for teachers has been effective in that a teacher-led PD Committee works in concert with the administration to ensure that the focus of adult learning is aligned with campus needs. Students can engage in credit recovery courses during the school day, as credit recovery is a part of the master schedule. This ensures that students who need to make up classes still have the opportunity to earn a diploma on time and graduate with their peers. The school continues to review data related to LTEL, and courses are designed to ensure that language acquisition and proficiency are prioritized.

A description of any changes made to the planned goal, metrics, target outcomes, or actions for the coming year that resulted from reflections on prior practice.

To better align with the intent behind our reported outcomes, we have updated the way we describe our expected outcomes. Specifically, we have replaced the "%" symbol with "percentage points" in all of our metric descriptions. This change provides a clearer representation of our schoolwide and student group progress and impact. By using "percentage points," we emphasize absolute changes rather than proportional ones, better reflecting the spirit of the metric outcomes and progress we seek to achieve.

Following continuous review of our LCAP actions as it relates to educational partner engagement and the LCAP instructions, we have made the following changes to the following LCAP actions:

All actions were implemented as planned and there were no substantive differences between planned actions and implementation. All actions implemented were in alignment with consistent practices throughout the years. The School Advisory Council (SAC) and District English Learner Advisory Council (DELAC) held monthly meetings and engaged in any necessary follow-up that came forward in such meetings. All communication tools, such as Parent Square and needed mailings, were also done in alignment with consistent practices.

There were no material differences between planned expenditures and estimated actual expenditures.

All actions were effective in supporting our metric outcomes. Focus is on ensuring action effectiveness in future school years. The parent engagement activities implemented have been highly effective in capturing the voices and opinions of parents. ParentSquare has been an effective communication tool to ensure parents are abreast of all happenings and opportunities on the campus. Such communication is done regularly by direct contact from the office and teachers. This has provided access to the school community and knowledge of academic interests on the campus. The school has been successful in developing multiple community partners, including but not limited to West LA College, which provides expanded dual enrollment opportunities, What's Your Cause (WYC), which provides students with exposure to exciting career pathways, UCLA's EAOP program, 826LA, CSUDH Steam Max program, multiple colleges and universities that provide tours and access to student support programs, and beyond.

To better align with the intent behind our reported outcomes, we have updated the way we describe our expected outcomes. Specifically, we have replaced the "%" symbol with "percentage points" in all of our metric descriptions. By using "percentage points," we emphasize absolute changes rather than proportional ones, better reflecting the spirit of the metric outcomes and progress we seek to achieve.

### **Additional Concentration Grant Funding**

A description of the plan for how the additional concentration grant add-on funding identified above will be used to increase the number of staff providing direct services to students at schools that have a high concentration (above 55 percent) of foster youth, English learners, and low-income students, as applicable.

Our LEA has strategically invested Additional Concentration Grant funding to expand our team of highly qualified staff who deliver meaningful, student-centered services to our thriving unduplicated student populations. Below, we share how these investments are enhancing educational equity and opportunity for students eligible for Free and Reduced-Price Lunch, English Learners, and students in foster care. This funding has allowed us to increase the number of credentialed educators who provide personalized academic support, empowering students to meet and exceed grade-level expectations. We have also hired instructional staff who are expertly trained in implementing the i-Ready diagnostic and instructional program. These educators design and facilitate individualized learning pathways that build on each student's strengths and ensure progress toward academic success. Schools demonstrating a strong opportunity for growth through diagnostic tools and tailored instruction received additional staff to maximize the benefits of the i-Ready program. Furthermore, grant funds support the hiring of credentialed elective teachers who engage students in enriching, project-based learning across STEM and the arts, helping students explore their interests and develop real-world skills. As part of our commitment to student well-being and engagement, we are prioritizing efforts to support consistent attendance. By investing in additional staff dedicated to attendance initiatives, and partnering with programs such as Everyday Labs and Attendance Works, we are creating stronger connections between school and home that support students' daily engagement and sense of belonging. To further elevate the success of our English Learners, we have dedicated grant funding to staff who implement the Ellevation platform, enabling educators to access targeted instructional strategies that affirm linguistic assets and accelerate language development. We recognize and honor the resilience and brilliance of our students in foster care and those experiencing homelessness. Our LEA uses grant funds to support additional credentialed staff who implement specialized advisory programs that address both the social-emotional and academic needs of these students. Summer Bridge programs, staffed with caring educators, offer transitional support that helps students build confidence and community as they move between grade levels or school sites. In addition, we have

invested in hiring case managers and partnering with community-based mental health organizations to provide holistic, trauma-informed support, ensuring students have access to the resources they need to thrive both in and out of the classroom.
