### Narrative Description: Prop 28 Arts Education Program(s) Funded

In the 2023-2024 school year, Alain Leroy Locke College Preparatory Academy moved from a 7-period bell schedule model to an 8-period model in order to strengthen intervention supports for students. By hiring a new full-time music teacher for FY 24 using AMS funding, Locke was able to adapt to the 8-period model and expand course offerings in its music program to better serve special populations (including but not limited to students with disabilities and emergent bilinguals) and ensure that all students have access to the music program. The expansion of the music program in FY24 included new courses as well as increased sections of existing courses: 1 new section of Percussion, 2 additional sections of Sheltered Modern Band for emergent bilingual students, and 1 new section of Modern Band for students with mild to moderate disabilities. In addition to hiring an FTE to expand the music program, Locke has also invested in technology in preparation for an FY25 launch of a new digital arts course.
